THE KINGSTON UPON THAMES (PARKING PLACES)
(KINGSTON) (AMENDMENT NO 16) TRAFFIC ORDER 2006

1. Notice is hereby given that the Council of the Royal Borough of Kingston upon Thames, on 29 December 2006, made the above Orders under sections 6, 45, 46, 49 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Orders, which will come into force on 8 January 2007, will be to:

(a) introduce two additional 1-hour “pay and display” parking bays on the north side of Fife Road (outside No 19) at which the rate of charge would be £2 per hour. The bays would operate between 8.30 am and 6.30

pm on Mondays to Saturdays, and between 11.00 am and 5.00 pm on Sundays;

(b) revise the existing waiting and loading restrictions in lengths of Fife Road, so that they would apply "at any time";

(c) extend the existing loading restrictions (7.00 am to midnight) on the north side of Fife Road, so that they would apply outside Nos 15 and 17.

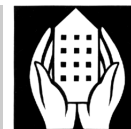

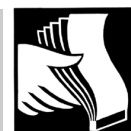
