GREENFORD ROAD (SUDBURY HILL)

THE EALING (WAITING AND LOADING RESTRICTION) (SPECIAL PARKING AREA) (AMENDMENT NO.) ORDER 200*

THE EALING (FREE PARKING PLACES) (NO. 2) (AMENDMENT NO. **) ORDER 200*

THE EALING (FREE LOADING PLACES) (AMENDMENT NO.) ORDER 200*

1. NOTICE IS HEREBY GIVEN that the London Borough of Ealing propose to make the above mentioned Orders under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Waiting Restriction Order would be:

(a) to change certain existing waiting restrictions in the Greenford Road Service Road, fronting Nos. 1211/1239 and Nos. 1283/1301, so that they would apply at any time;

(b) to impose waiting restrictions applying between 10am and 11 am on Mondays to Fridays in the length of the south-east side of Greenford Road lying between a point 5.00 metres south-west of a point opposite the party wall of Nos. 1514 and 1516 Greenford Road and a point 10.00 metres south-west of the south-western kerb-line of Horsenden Avenue.

3. The general effect of the Free Parking Places Order would be:

(a) to provide a free 30 minute maximum stay stop and shop parking place in the length of footway specified in Schedule 1 to this Notice which would operate between 8am and 7pm on Mondays to Saturdays. Return by vehicles to this parking place would be prohibited for one hour;

(b) to vary the times of operation of the free parking places in lengths of specified in Schedule 2 to this notice so that they would operate between 8am and 7pm on Mondays to Saturdays and the maximum stay by vehicles reduced to 90 minutes. Return by vehicles to these parking places would be prohibited for one hour;

(c) revoke certain free parking places in the Greenford Road Service Road, fronting Nos. 1211/1239 and Nos. 1283/1301.

4. The general effect of the Free Loading Places Order would be to provide a free loading place available for loading by vehicles between 8am and 7pm on Mondays to Saturdays without time limit in the length of road specified in Schedule 3 to this notice.

5. The Orders and other documents giving more detailed particulars of the Orders are available for inspection during normal office hours on Mondays to Fridays inclusive at Mouchel Parkman, 6th Floor, 58 Uxbridge Road, Ealing, London W5 2ST, until 6 weeks have elapsed from the date on which either the Orders are made or the Council decides not to make the Orders.

All objections must specify the grounds on which they are made.

SCHEDULE 1 (30 minutes maximum stay free parking place)

Greenford Road Service Road, fronting Nos. 1211/1239 and Nos. 1283/1301

the south-east side, between a point 5 metres south of its north-easternmost junction with the main carriageway of Greenford Road south-westwards for a distance of 25 metres. (Vehicles are required to park with all four wheels on the footway in this parking place).

SCHEDULE 2 (90 minutes maximum stay free parking place)

Greenford Road, the north-west side, from a point opposite the party wall of Nos. 1211/1239 and 1213/1241 Greenford Road north-eastwards for a distance of 39 metres.

Greenford Road Service Road, fronting Nos. 1211/1239 and Nos. 1283/1301

the north-west side, from a point 3.5 metres south-west of the party wall of Nos. 1211/1239 and 1213/1241 Greenford Road to a point 3 metres south-west of a point opposite the north-eastern wall of Nos. 1231/1259 Greenford Road.

Greenford Road Service Road, fronting Nos. 1211/1239 and Nos. 1283/1301

the north-west side, from a point 3.10 metres north-east of a point opposite the south-western wall of Nos. 1267/1285 Greenford Road to a point 1.60 metres south-west of a point opposite the north-eastern wall of Nos. 1283/1301 Greenford Road.

SCHEDULE 3 (loading place)

Greenford Road Service Road, fronting Nos. 1211/1239 and Nos. 1283/1301

The north-west side, from a point 1.60 metres south-west of a point opposite the north-eastern wall of No. 1261 Greenford Road south-westward for a distance of 9.73 metres and which has a width throughout of 1.8 metres (230899)

1. NOTICE IS HEREBY GIVEN that the London Borough of Hammersmith and Fulham, propose to make the above-mentioned Order under the powers granted by sections 6, 45, 46, 49 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 as amended by the Road Traffic Act 1991.

2. The general effect of the Hammersmith and Fulham (Free Parking Places) (Disabled Persons) (Amendment No. 8) Order 2007 will be to amend the Hammersmith and Fulham (Free Parking Places) (Disabled Persons) Order 2005 so as to:

(a) designate further free parking places for vehicles displaying a valid disabled person's blue badge at the locations set out in Schedule 1 to this notice;

(b) revoke the disabled person's free parking place located outside No. 8 Addison Bridge Place and 15 metres west of Pankhurst House, Du Cane Road.

3. A copy of the above proposed Order and of the Order being amended, together with other documents giving more detailed particulars of the Order may be inspected at the offices of the London Borough of Hammersmith and Fulham as detailed below, during normal office hours until 6 weeks have elapsed from the date on which either the Order is made or the Council decides not to make the Order.

4. Any person wishing to object to the proposed Order or make other representations should send a statement in writing of either their objection or representations, stating the grounds of their objection to the Network Management Group, The Environment Department, Town Hall Extension, King Street, Hammersmith, W6 9JU, until the expiration of 21 days from the date on which this notice is published.
