THE CAMDEN (20 MPH SPEED LIMIT) (BELSIZE AREAS) TRAFFIC ORDER 2007

NOTICE IS HERBY GIVEN that the Council propose to make the above-mentioned Order under Section 84 of the Road Traffic Regulation Act 1984.
