1. NOTICE IS HEREBY GIVEN that Heathrow Airport Limited on 18th July 2007 made the above-mentioned Orders under sections 6, 84 and 124 of the Road Traffic Regulation Act 1984, having effect by virtue of Sections 1, 2 and 65 of the Airports Act 1986.

2. The general effect of the Orders will be to substitute, revise and consolidate the existing 'Prescribed Routes', 'Prohibition of Driving', 'Speed Limits', 'Waiting and Loading Restriction', 'Urban Clearway' and 'Prohibition of Stopping on Cab Ranks' Orders. The locations and hours of operation of any existing restriction or prohibition will remain unchanged.

3. A copy of each of the Orders, which will come into operation on 18th July 2007, can be inspected between 9.00a.m and 4.00 p.m. on Mondays to Fridays inclusive until the end of six weeks from the date on which the Orders were made at the offices of the *General Manager, Commercial Transport Solutions, Heathrow Airport Limited, Second Floor, World Business Centre 2, Newall Road, Heathrow Airport, Hayes, Middlesex TW6*

4. Any person desiring to question the validity of any of the Orders or of any provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984 or that any of the relevant requirements thereof or of any relevant regulations made thereunder has not been complied with in relation to any of the Orders may, within six weeks of the date on which the Orders were made, make application for the purpose to the High Court.
