**PROPOSED REVOCATION OF A LENGTH OF 7AM TO 7PM WAITING RESTRICTION IN LADBROOK ROAD, REVOCATION OF A PARKING BAY IN PAMPISFORD ROAD AND INTRODUCTION OF 'AT ANY TIME' WAITING RESTRICTIONS IN VARIOUS LOCATIONS, CROYDON**

1. NOTICE IS HEREBY GIVEN that Croydon Council proposes to make Traffic Orders under the relevant sections of the Road Traffic Regulation Act 1984 and the Local Government Act 1985.

2. The general effect of the Order would be to
