NOTICE IS HEREBY GIVEN that the London Borough of Ealing Council, in connection with the introduction of a controlled parking zone (DD) in the Bollo Bridge area, on 6th December 2007 made the above-mentioned Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended by the Local Government Act 1985. 2. The general effect of the Ealing (Bollo Bridge) (Residents Parking

Places) Order 2007 will be:

(a) to introduce parking places for the use of residents, their visitors and business users in lengths of Acton Lane W3 (between Salisbury Street and the railway bridge), Avenue Road (between Winchester Street and Langley Drive), Bollo Bridge Road (between Acton Lane and All Saints Road), Brouncker Road, Leythe Road, Meon Road, Newton Avenue, Park Road East and Ramsay Road;

(b) to provide that the parking places will operate between the hours of 9.30am and 5.30pm on Mondays to Fridays inclusive; and

(c) to provide that passenger vehicles, goods carrying vehicles, motorcycles and disabled persons vehicles may be left in a parking place without limitation on time during the controlled hours and that with the exception of motorcycles and disabled persons vehicles, a valid permit or voucher must be displayed whilst parked therein.

The general effect of the Ealing (Free Parking Places) (Disabled Persons) (Amendment No. 73) Order 2007 will be to introduce a free parking places for vehicles displaying the disabled driver's blue badge parking permit without limit on time in Acton Lane, Bollo Bridge Road, Meon Road and Ramsay Road.

4. The general effect of the Ealing (Waiting and Loading Restriction) (Special Parking Area) (Amendment No. 332) Order 2007 will be to amend existing waiting restrictions or impose new waiting restrictions that will apply at any time at road junctions or between the controlled hours of 9.30am and 5.30pm on Mondays to Fridays inclusive in lengths of Acton Lane W3 (between Salisbury Street and Winchester Street), Avenue Road (between Winchester Street and Langley Drive), Bollo Bridge Road between Acton Lane and All Saints Road), Brouncker Road, Leythe Road, Meon Road, Newton Avenue, Park Road East and Ramsay Road;

5. The general effect of the Ealing (Free Parking Places) (No.2) (Amendment No.94) Order will be to provide limited time free parking places in Acton Lane, Bollo Bridge Road and Meon Road operating between 9.30am and 5.30pm on Mondays to Fridays. The parking places will have a maximum length of stay of 30 minutes (60 minutes in Bollo Bridge Lane) with no return to the parking place for 1 hour.
