THE BRENT (PARKING PLACES) (NO.) ORDER 200 THE BRENT (PARKING PLACES) (NO.) ORDER 200 THE BRENT (WAITING AND LOADING RESTRICTION) (AMENDMENT NO.) ORDER 200

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Brent propose to make the above mentioned Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by section 8 of and Part 1 of Schedule 5 to the Local Government Act 1985, the Parking Acts of 1986 and 1989 and the Road Traffic Act 1991.

2. The general effect of the 'Parking Places' Order would be:-

(a) modify existing dual-use bays into permit holders only bays in the streets specified in Schedule 1 to this Notice;

(b) modify existing permit holders only bay into a 1-hour only pay and display bay with no return for 2 hours (10.00 a.m. to 9.00 p.m. Mondays to Saturdays inclusive) in Hoveden Road, the south-west side, from a point 10.00 metres north-west of Walm Lane northwestward for a distance of 16.00 metres;

(c) transfer the existing pay and display meters bays and the resident and visitor permit holders and essential / key worker users / business permit holder bays in the streets located in MC Zone specified in Schedule 2 to this Notice into MA Zone;

(d) designate parking places that would operate between 12.30 p.m. and 2.30 p.m. on Fridays in addition to existing restrictions in certain lengths of the streets specified in Schedule 3 to this Notice and specify that:—

(i) each parking place may be used, subject to the provisions of the Order, for the leaving during the permitted hours of such vehicles as are passenger vehicles, goods carrying vehicles or invalid carriages displaying a valid parking ticket or permit. Motor cycles park free;

(ii) the maximum initial period for which a vehicle, displaying a valid parking ticket may be left during the permitted hours in the parking places specified in Schedule 3 to this Notice would be 2 hours;

(iii) the charge for short term parking in the parking places specified in Schedule 3 to this Notice would be 30 pence for 20 minutes, 60 pence for 40 minutes, $\pounds 1.50$ pence for 1 hour and $\pounds 3.30$ for 2 hours, the tickets for which would be issued by pay and display meters.

3. The general effect of the 'Waiting and Loading Restrictions' Order would be further to amend the Brent (Waiting and Loading Restriction) Order 1979, so that:—

(a) waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) would be changed so that such prohibition would apply 'at any time' in the lengths of streets specified in Schedule 4 to this Notice;

(b) the hours during which the existing prohibition applies on waiting by vehicles for the purpose of delivering or collecting goods or loading or unloading a vehicle for a period of more than 20 minutes in the same place would be changed so that such prohibition will apply between 11.00 a.m. and 6.30 p.m. throughout the week in the lengths of streets specified in the Schedule 4 to this Notice.

4. A copy of each of the proposed Orders, of relevant Orders of 1979, 2002 and 2005 (and of the Orders which have amended those Orders) and of the Council's statement of reasons for proposing to make the Orders and of a map which indicates each length of road to which the Orders relate can be inspected during normal office hours on Mondays to Fridays inclusive until the expiration of a period of 21 days from the date on which this notice is published at:—
