#### THE BOROUGH OF BOSTON (OFF-STREET PARKING PLACES AND CONTROLLED PARKING ZONE) AMENDMENT ORDER 2008

Notice is hereby given that Boston Borough Council (hereinafter called "the Council") proposes to make an Order under sections 35(1) and 46(1) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and all other enabling powers, to vary the existing Borough of Boston (Off-Street Parking Places and Controlled Parking Zone) Order 2002, after consulting Lincolnshire County Council, the Chief Officer of Police, the Road Haulage Association, the Freight Transport Association and other organisations representing persons likely to be affected by this Order.

The effect of this will be:

- (a) To vary and increase the car parking charges from 1 May 2008.
- (b) To increase the cost of Traders Permits from 1 May 2008.
- (c) To introduce an option for half hour parking on the Market Place from 1 May 2008.
