## Road Traffic Acts

### London Borough of Camden

**THE CAMDEN (PARKING PLACES) (CA-K) (SPA) (AMENDMENT NO.7) TRAFFIC ORDER 2007**

**THE CAMDEN (DISABLED PERSONS) (PARKING PLACES) (AMENDMENT NO.30) TRAFFIC ORDER 2007**

**THE CAMDEN (PARKING PLACES) (CA-B)(SPA) (AMENDMENT NO.33) TRAFFIC ORDER 2007**

NOTICE IS HEREBY GIVEN, that the Council of the London Borough of Camden on 03 March 2008 made these Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985, details of which were previously published in the London Gazette on 22 November 2007.

The changes that effect the (CA-K) Order will be;

- to add more bays to the existing residents and pay & display parking in that part of Belsize Road, between Abbey Road and Fairfax Road and to relocate a disabled persons parking place
- to change one resident parking space into a disabled persons parking place outside Douglas Court, Quex Road and 39 Priory Road.

- to change three resident spaces into pay & display parking place in Kilburn Priory.

The changes that effect the (CA-B) Order will be;

- to remove one resident 5.0 metre length space outside 5 Belsize Lane to make a new vehicle crossover and replace it outside no.28 Belsize Lane.

A copy of the Orders, which will come into force on 17 March 2008, and of the Council's statement of reasons for proposing to make the Order may be inspected at the Culture and Environment Reception, fifth floor, Camden Town Hall, Argyle Street, WC1H 8EQ.

Any person wishing to question the validity of the Orders or of any the provision contained therein on the grounds that they are not within the relevant powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or any Instrument made under it has not been complied with in relation to the order, may, within six weeks of the date on which the Order was made, make application for the purpose to the High Court.
