DAVIES LANE AND PASTURE'S PATH

THE WALTHAM FOREST (WAITING AND LOADING RESTRICTION) (AMENDMENT NO. *) ORDER 200*

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Waltham Forest (hereinafter called "the Council") propose to make the above-mentioned Order under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985(b), and of all other powers thereunto enabling.

2. The general effect of the Order would be to further amend the Waltham Forest (Waiting and Loading Restriction) Order 1977, so that waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) would be prohibited "at any time" in parts of Pasture's Path as specified in Schedule 1 to this Notice and certain lengths of "at any time" waiting restrictions would be removed from Davies Lane as specified in Schedule 2 to this Notice.

3. A copy of the Order, the Council's statement of reasons for proposing to make the Order and of plans showing the locations and effects of the Order, can be inspected during normal office hours on Mondays to Fridays inclusive until the end of 21 days from the date of this Notice at (a) The Information Desk, Town Hall, Forest Road, Walthamstow, E17; (b) The Waltham Forest Direct Shop, 772-776 High Road, Leyton, E10 and (c) The Reception Desk, The London Borough of Waltham Forest, Low Hall, Argall Avenue, London, E10 7AS.

Pasture's Path

(i) between a point 2.5 metres north-east of its junction with Davies Lane and a point 21 metres north-east of that junction;

(ii) between a point 27 metres south-west of its junction with Lister Road and that junction;

(b) the south-east side

(i) between a point 2.5 metres north-east of its junction with Davies Lane and a point 21 metres north-east of that junction;

(ii) between a point 27 metres south-west of its junction with Lister Road and that junction;

Davies Lane

(a) the north side, between a point 11.5 metres east of its junction with High Road Leytonstone and a point 25 metres east of that junction;

(b) the south side, between a point 9.5 metres east of its junction with High Road Leytonstone and a point 19.5 metres east of that junction.

THE WALTHAM FOREST (BUS STOP CLEARWAYS) (AMENDMENT NO. *) ORDER 200*

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Waltham Forest (hereinafter called "the Council") propose to make the above-mentioned Orders under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985(b), and of all other powers thereunto enabling.

2. The general effect of the Orders would be, in respect of:—

(a) the Waiting and Loading Order, to further amend the Waltham Forest (Waiting and Loading Restriction) Order 1977, so that waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) would be prohibited "at any time" in parts of Fulbourne Road and its junctions, as specified in Schedule 1 to this Notice; and

(b) the Bus Stop Clearways Order, to further amend the Waltham Forest (Bus Stop Clearways) (No. 1) Traffic Order 2001 so as to:

(i) extend the bus stop clearway south-east of No. 115 Fulbourne Road, as specified in Schedule 2 to this Notice;

(ii) amend certain waiting restrictions times at bus stop clearways on Fulbourne Road; and

(iii) bring the Order in line with the on street layout.
