1. NOTICE IS HEREBY GIVEN that the London Borough of Ealing, propose to make the above-mentioned Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Special Permit Order would be to provide parking places for car club vehicles in Acton Lane W4, Campbell Road, Cedar Grove, Cunnington Street, Disraeli Road, Dryden Avenue, Erlesmere Gardens, Gunnersbury Gardens, Hastings Road, Messaline Avenue, Northcroft Road, Olive Road, St. Aidan's Road, Seaford Road, Tennyson Road, The Grove, Third Avenue, Westbury Road, Weymouth Avenue and Woodville Road. Car Club vehicles using these parking places would be required to display special parking permits which would cost £250 per annum. The parking places would operate 24 hours a day 7 days a week.

3. The general effect of the other Parking Places Orders would be to amend existing orders so as:-

(a) to convert lengths of residents/permit parking places in Cunnington Street, Disraeli Road, Gunnersbury Gardens, Hastings Road, Third Avenue Westbury Road and Weymouth Avenue, to provide the car club bays mentioned in paragraph 2 in those roads;

(b) to convert existing bays in free parking place in Acton Lane W4 and Woodville Road to provide the car club bays mentioned in paragraph 2 in those roads.

4. The Orders, precise details concerning the lengths of roads affected and other documents giving more detailed particulars of the Orders are available for inspection between 9 a.m. and 5 p.m. Mondays to Fridays inclusive at Mouchel Limited, 6th Floor, 58 Uxbridge Road, Ealing, London W5 2ST, until 6 weeks have elapsed from the date on which either the Orders are made or the Council decides not to make the Orders.
