

and Welsh Ministers for confirmation of byelaws made under the Water Resources Act 1991 and to the Secretary of State for Environment, Food and Rural Affairs and Scottish Ministers for the byelaw made under the Scotland Act 1998 (Border Rivers) Order 1999. The byelaws will:—

- Maintain the existing measures aimed at protecting spring salmon for a further ten years.
- Ban the sale of rod caught salmon and sea trout in England and Wales.
- Introduce carcass tagging and associated log books for salmon and sea trout caught by other means.

The byelaws protecting early running salmon are considered necessary as stocks of spring salmon are still fragile and we do not believe that their exploitation can be justified at the present time.

The byelaws banning the sale of rod caught salmon and sea trout and the carcass tagging byelaw for fish caught by other means are intended to implement recommendations of the Salmon and Freshwater Fisheries Review which reported in 2000 after an extensive period of public consultation.

Copies of the byelaws have been deposited at the offices of the Agency at the addresses shown here and will be open to inspection free of charge from Monday to Friday during normal office hours from the date of publication of this notice until 14th July 2008. During consideration of the proposal, the Secretary of State may formally request further information from the Company to supplement the Environmental Statement and materially relevant information may also be generated. If that happens, further public notices will give advice on how representations may be made to the Secretary of State on this material.

Following receipt of all views and representations the Secretary of State will either grant or refuse consent for the proposal (with or without conditions). This may involve holding a public inquiry first, depending on whether there is a statutory objection from the relevant planning authority, or the Secretary of State decides to exercise his discretion to call a public inquiry in the light of objection by other persons.
