TOWN AND COUNTRY PLANNING ACT 1990

SECTION 69 OF THE PLANNING (LISTED BUILDINGS AND CONSERVATION AREAS) ACT 1990

AMENDMENT OF CONSERVATION AREA: REEPHAM

NOTICE is hereby given that the Broadland District Council, at its meeting on 12 May 2008, in pursuance of their powers under the above Act, have reviewed the above named conservation area, designated on 1 September 1972 and amended May 1978, and determined that the boundary of the conservation area should be amended. All of which area, as amended, is designated on a plan kept at the offices of Broadland District Council, Thorpe Lodge, Yarmouth Road, Norwich, NR7 0DU, where it may be inspected free of charge by members of the public during normal office hours and where copies of the plan may be obtained.

The principal effects of such designation are that:

- (i) Consent must be obtained from the relevant Planning Authority for the demolition of any building in the Area;
- (ii) It is a criminal offence for any person proposing to cut down, top, lop, uproot, wilfully damage or wilfully destroy any tree in the Area except with the consent of the relevant Planning Authority. To obtain the relevant consent, the person proposing to do any work on trees in the Area is required to give six weeks prior notification in writing to the relevant Planning Authority of their intention, unless the trees are already protected by a tree preservation order, in which case an application for consent is required;
- (iii) proposals for the preservation and enhancement of the Area will be published by the relevant Planning Authority at the appropriate time;
- (iv) Permitted development rights are more restricted in the Area than in other areas;
- (v) Any person wishing to display an illuminated advertisement in the Area must not do so without the express consent of the relevant Planning Authority;
- (vi) In carrying out its functions under the Planning Acts and in particular determining applications for planning permission and listed building consent, the relevant Planning Authority will take into account the desirability of preserving or enhancing the character or appearance of the area;
- (vii) Planning applications for development which would, in the opinion of the relevant Planning Authority, affect the character or appearance
