THE BEXLEY (20 MPH SPEED LIMIT) TRAFFIC ORDER 200X

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Bexley propose to make the above mentioned Order under sections 84 of the Road Traffic Regulation Act 1984, as amended by Section 8 of and Part 1 of Schedules 5 and 9 to the Local Government Act 1985.

2. The general effect of the Bexley (20 mph Speed Limit) Traffic Order 200X would be to introduce a speed limit of twenty miles per hour in the following roads:—

- (a) the whole length in Buxton Road, Erith; Clydon Close, Erith; Colyers Close, Erith; Defoe Close, Erith; Doyle Close, Erith; Drummond Close, Erith; Elm Grove, Erith, Selkirk Drive, Erith; and Swallow Close, Erith;
- (b) Hind Crescent, Erith: between a point 30.0 metres northwest of Avenue Road, Erith and its junction with Avenue Road, Erith; and
- (c) Lesney Park, Erith: between Mortimer Road, Erith and Avenue Road, Erith.

3. A copy of the proposed Order, the Bexley (20 mph Speed Limit) Traffic Order 200X; the Council's statement of reasons for proposing to make the Order, and of a map which indicates the length of roads to which the Order relates can be inspected during normal office hours

THE BEXLEY (WAITING AND LOADING RESTRICTION) (AMENDMENT NO. 18) TRAFFIC ORDER 2008

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Bexley on 2nd June 2008 made the above mentioned Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by Section 8 of and Part 1 of Schedule 5 to the Local Government Act 1985.

2. The general effect of the Bexley (Sidcup Station Area)(Parking Places) (Amendment No. 18) Traffic Order 2008 would be to:-

- (a) Introduce resident permit bays in Little Birches; Gloucester Avenue; Longlands Road, and York Avenue; Sidcup;
- (b) Introduce free parking bays in Little Birches; Gloucester Avenue; Longlands Road, and York Avenue; Sidcup;

3. The general effect of the Bexley (Waiting and Loading Restriction)(Amendment No.18) Traffic Order 2008 would be to:-

- (a) Introduce 'at any time' waiting restrictions in parts of Little Birches; Gloucester Avenue; Longlands Road, and York Avenue; Sidcup;
- (b) Introduce 'Monday to Friday, 1.00pm to 3.00pm' waiting restrictions in parts of Little Birches; Gloucester Avenue; Longlands Road, and York Avenue; Sidcup;

4. A copy of the proposed Orders, the Bexley (Sidcup Station Area) (Parking Places) Traffic Order 1998 (and the Orders which have amended that Order), the Bexley (Waiting and Loading Restriction) Traffic Order 2007 (and the Orders which have amended that Order); the Council's Statement of Reasons for making the Orders and a map which indicates the length of roads to which the Orders relate can be inspected, during normal office hours on Mondays to Fridays inclusive, in the Contact Centre, London Borough of Bexley, Civic Offices, Bexleyheath, Kent DA6 7LB.

Persons desiring to question the validity of the Orders or of any provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984, or that any of the relevant requirements thereof or of any relevant regulations made thereunder has not been complied with in relation to the Orders may, within six weeks of the day on which the Orders were made, make application for the purpose to the High Court.
