(b) extend the residents' parking place outside No. 1 Hamilton Terrace 6 metres (1 car space) towards St. John's Wood Road; and

(c) introduce 6 metres (1 car space) of residents' parking outside No. 23 Hamilton Terrace.

ROAD TRAFFIC REGULATION ACT 1984

THE A49 TRUNK ROAD (NORTH OF HOPE UNDER DINMORE, HEREFORDSHIRE) (DERESTRICTION) ORDER 200

The Secretary of State for Transport hereby gives notice that she intends to make an Order under sections 82(2) and 83(1) of, and paragraph 27(1) of Schedule 9 to, the Road Traffic Regulation Act 1984 on the A49 Trunk Road, north of Hope under Dinmore in the District of the County of Herefordshire.

The effect of the Order would be to maintain the national speed limit on a length of the A49 Trunk Road between a point 86 metres north of the centrepoint of its roundabout junction with the B4361 and a point 168 metres north of its junction with the A417, north of Hope under Dinmore in the District of the County of Herefordshire, which would otherwise be subject to a speed limit of 30 miles per hour as a result of the street lighting installed on it.

The Lichfield Council (hereinafter called "the Council") in exercise of their powers under Section 35 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "The Act") and all other enabling powers with the consent of the Staffordshire County Council in accordance with Section 39(3) of the Act and after consulting the Chief Officer of Police in accordance with Section 124 (1) (c) and Part III of Schedule 9 to the Act made an Order the effect of which was to consolidate the provisions of the Lichfield District Council (Off-Street Parking Places) Order 2005, and subsequent Variation Notices into one Order, and to:

- Revise the charges for vehicles using car parks in the District on Sunday;
- The introduction of charges for using car parks at Greenhough Road;
- The incorporation of a number of free car parks into the Order
