**The Highways Agency** ROAD TRAFFIC REGULATION ACT 1984 THE A69 TRUNK ROAD (DENTON BURN INTERCHANGE TO WEST DENTON INTERCHANGE) (50 MILES PER HOUR SPEED RESTRICTION) ORDER

NOTICE IS HEREBY GIVEN that the Secretary of State for Transport proposes to make an Order under section 84(1)(a) and (2) of, and paragraph 27(1) of Schedule 9 to, the Road Traffic Regulation Act 1984, on the A69 Trunk Road in the District of Newcastle upon Tyne.

The effect of the Order, if made, will be to impose a 50mph speed restriction on the A69 from its junction with the A1 Denton Burn Interchange Roundabout westwards for 1140 metres, and on the A69 westbound exit slip road and eastbound entry slip road at the B6528 West Denton Interchange.
