#### **THE BARNET (WAITING AND LOADING RESTRICTION) (CIVIL ENFORCEMENT AREA) (AMENDMENT NO. 2) TRAFFIC ORDER 2008**

NOTICE IS HEREBY GIVEN that the Council of the London Borough of Barnet have made on 28th August 2008 the above-mentioned Order under Sections 6, and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and all other enabling powers. In order to prevent obstructive parking, improve traffic flow and general road safety, the general effect of the Order would be to introduce new waiting restrictions Lullington Garth, Frith Lane and Partingdale Lane NW7, as follows.

At any time waiting restrictions would be provided around the junctions of Lullington Garth, Frith Lane and Partingdale Lane (by upgrading existing Monday to Friday 8am to 5pm waiting restrictions).

At any time waiting restrictions would be provided on certain lengths of Frith Lane (new waiting restrictions and by upgrading existing Monday to Friday 8am to 5pm waiting restrictions) and Lullington Garth (by upgrading existing Monday to Friday 8am to 5pm waiting restrictions).

#### **THE BARNET (HENDON CONTROLLED PARKING ZONE) (PARKING PLACES) (AMENDMENT NO. 4) TRAFFIC ORDER 2008**

NOTICE IS HEREBY GIVEN that the Council of the London Borough of Barnet on 28th August 2008 made the above orders ("the Orders") under Sections 6 and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and all other enabling powers.

In order to prevent obstructive parking, improve traffic flow and general road safety in the vicinity of certain schools within the borough, the general effect of the Orders will be to introduce new and amend existing waiting restrictions as follows.

#### **Holly Park School, N11**

At any time waiting restrictions will be provided at the junction of Bellevue Road and The Crescent, and Monday to Friday 8.30am to 9.30am, and 2.30pm to 4.30pm waiting restrictions will be provided at the junction of Bellvue Road and Holly Park Road.

#### **Lyonsdown School, Barnet**

At any time waiting restrictions will be provided at the junction of Gloucester Road and Richmond Road.

#### **Sacred Heart and All Saint's Schools, N20**

At any time waiting restrictions will be provided at the junction of Oakleigh Road North and Russell Road., and on certain lengths of Oakleigh Road North.

#### **Our Lady of Lourdes School, N12**

At any time waiting restrictions will be provided at the junctions of Bow Lane and Clifton Road, and Bow Lane and Heatherdene Close.

#### **Bell Lane School, NW4**

At any time waiting restrictions will be provided at the junction of Bell Lane and Green Lane by upgrading the existing Monday to Saturday 8am to 6.30pm waiting restrictions. At any time waiting restrictions will also be provided in the vicinity of Nos. 102 and 104 Bell Lane. "No Stopping" school keep clear markings, with an operation time of Monday to Friday 8am to 9.30am, and 2.45 to 4.15pm will be provided on Bell Lane outside Nos. 86 to 100 Bell Lane.

#### **Dollis Infant and Junior Schools, NW7**

At any time waiting restrictions will be provided around the junctions of Pursley Road and Broadfield Avenue, Pursley Road and Milesplit Hill, Pursley Road and Salcombe Gardens, and Pursley Road and Bittacy Rise. At any time waiting restrictions will also be provided on lengths of Pursley Road opposite its junctions with Milesplit Hill and Bittacy Rise.

#### **Mill Hill School, NW7**

The "no stopping" school keep clear markings on The Ridgeway, NW7 in the vicinity of Millers Close will be extended in length.

#### **St Mary's and St John's School, NW4**

At any time waiting restrictions will be provided outside Nos. 1a to 1c Prothero Gardens by upgrading the existing Monday to Friday waiting restrictions and removing the existing free parking place. A free parking place will be provided on Prothero Gardens outside Nos. 37 to 44 Quadrant Close. The restrictions of the no stopping school keep clear markings on Prothero Gardens will be amended from 8am to 9.30am & 2.45pm to 4.15pm, to Monday to Friday 8am to 5pm.

#### **St Joseph's Infant and Junior Schools, NW4**

At any time waiting restrictions will be provided at the junction of Colindeep Lane and Grove Gardens.

At any time waiting restrictions will also be provided on outside Nos. 12 to 22 Colindeep Lane.
