##### CHANGES TO DISABLED PERSON'S PARKING BAYS

1. NOTICE IS HEREBY GIVEN that the Common Council of the City of London propose to make changes to the operation of Disabled Person's Parking Bays by means of an order made under section 6 of the Road Traffic Regulation Act 1984.
