THE BROMLEY (WAITING AND LOADING RESTRICTION) ORDER 2003 (AMENDMENT NO. **) ORDER 2008.

(ELMSTEAD LANE, CHISLEHURST)

NOTICE IS HEREBY GIVEN that the Council of the London Borough of Bromley proposes to make the above-mentioned Order under Sections 6 and 124 of and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended by Section 8 of and Part 1 of Schedule 5 to the Local Government Act 1985, the Traffic Management Act 2004 and all other enabling powers.

The effect of the Order would be to introduce Waiting Restrictions as specified in the Schedule to this notice.

Details of prohibitions and exemptions for certain vehicles and persons are contained in the original Order of 2003.

A copy of the proposed order, of the plans of the scheme and of the Council's statement of reasons for proposing to make the Order can be inspected during normal office hours on Mondays to Fridays at the Bromley Civic Centre, Stockwell Close, Bromley, Kent.

ANY person wishing to object to the proposed Order should send a statement in writing of their objection and the grounds thereof to the Director of Environment, Civic Centre, Stockwell Close, Bromley, BR1 3UH, quoting reference ADE(TP)/RP/T100/508 not later than 5th November 2008.

Persons objecting to the proposed order should be aware that under the provisions of the Local Government (Access to Information) Act 1985, any comments received in response to this Notice may be open to public inspection.

WAITING RESTRICTIONS

No Waiting At Any Time:-

BROADHEATH DRIVE, Chislehurst, both sides, from the south eastern kerbline of Elmstead Lane south eastwards for a distance of 10m.

CROFT CLOSE, Chislehurst, both sides, from the south eastern kerbline of Elmstead Lane south eastwards for a distance of 10m.

ELMSTEAD LANE, Chislehurst, (a) the west side, (i) from the northern kerbline of Sundridge Avenue northwards to a point 15m south of the common boundary of Nos. 41 & 41a; (ii) from a point 1m south of the northern boundary of No. 49 north eastwards to the south western boundary of No. 55; (iii) from the north eastern boundary of No. 63 north eastwards to a point 9m north of a point opposite the common boundary of Nos. 64 & 66; (iv) from a point 5m north east of a point opposite the common boundary of Nos. 76 & 78 north eastwards for a distance of 15m; (v) from a point 6m north east of a point opposite the common boundary of Nos. 82 & 84 north eastwards to a point opposite the common boundary of Nos. 90 & 92; (vi) from a point opposite the north eastern flank wall of No. 98 north eastwards to a point 18m north east of a point opposite the south western boundary of No. 112; (vii) from the north eastern kerbline of St Keverne Road north eastwards to a point 11m north east of a point opposite the north eastern kerbline of Croft Close; (b) the east side, (i) from a point opposite the common boundary of Nos. 47 & 49 north eastwards to a point opposite the south western boundary of No. 55; (ii) from a point opposite the north eastern boundary of No. 63 north eastwards to the common boundary of Nos. 52 & 54; (iii) from the north eastern flank wall of No. 98 north eastwards to a point 11m north east of the north eastern kerbline of Croft Close.

GRANGE DRIVE, Chislehurst, both sides, from the south eastern kerbline of Elmstead Lane eastwards for a distance of 19m.

OLD MANOR WAY, Chislehurst, both sides, from the north western kerbline of Elmstead Lane north westwards for a distance of 11m.

ST KEVERNE ROAD, Chislehurst, the north east side, from the north western kerbline of Elmstead Lane north westwards for a distance of 10m.

THE UNNAMED ROAD lying between Nos. 104 and 112 Elmstead Lane, Chislehurst, both sides, from the south eastern kerbline of Elmstead Lane south eastwards for a distance of 10m.

No Waiting between 11.00am and 3.00pm on Mondays to Fridays inclusive:-

ELMSTEAD LANE, Chislehurst, (a) the west side, from a point 15m south of the common boundary of Nos. 41 & 41a northwards to a point 4m south of the common boundary of Nos. 41 & 41a; (b) the east side, from a point 18.29m north of the northern kerbline of Sundridge Avenue northwards to a point 5m south of the northern flank wall of No. 18.

No Waiting between 11.00am and 12noon on Mondays to Fridays inclusive:-

ELMSTEAD LANE, Chislehurst, the east side, from the common boundary of Nos. 52 & 54 north eastwards to the north eastern flank wall of No. 98.
