

2. The general effect of the Orders will be to:

- (a) relocate two existing residents' parking places opposite Nos. 4 to 12 Little Titchfield Street eastward by 7 metres (the westernmost parking place) and eastward by 9 metres (the easternmost parking place);
- (b) relocate two "Pay by Phone" parking bays on the south side of Little Titchfield Street (opposite the southern flank wall of No. 68 Great Portland Street) eastward by approximately 7 metres;
- (c) create a "Blue Badge" disabled persons' parking space on the south side of Little Titchfield Street (opposite the southern flank wall of No. 68 Great Portland Street);
- (d) introduce "at any time" waiting and loading restrictions on the south side of Little Titchfield Street outside the three vehicular entrances to Knighton House;
- (e) create a residents' parking place (2 spaces) outside Nos. 44 - 46 Great Titchfield Street; and
- (f) correct discrepancies between existing Orders and on-street markings.

3. The Orders, which will come into force on 27th October 2008, and other documents giving more detailed particulars of the Orders are available for inspection between 9 a.m. and 5 p.m. on Mondays to Fridays inclusive at West One, 59 Buckingham Gate, London SW1E 6AJ, until 3rd December 2008.

4. Any person desiring to question the validity of the Orders or of any provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984 or that any of the relevant requirements thereof or of any relevant regulations made thereunder have not been complied with in relation to the Orders may, within six weeks from the date on which the Orders were made, make application for the purpose to the High Court.

THE A46 TRUNK ROAD (CHARMY DOWN, NEAR BATH) (LAYBY CLOSURE) ORDER 2008

ROAD TRAFFIC REGULATION ACT 1984

THE A50 TRUNK ROAD (MEIR, STAFFORDSHIRE) (PROHIBITION AND RESTRICTION OF WAITING IN LAYBY) ORDER 2008

THE SECRETARY OF STATE FOR TRANSPORT hereby gives notice that he has made an Order under sections 1(1), 2(1) and (2) and 4(1) and (2) of the Road Traffic Regulation Act 1984 on the A50 Trunk Road at Meir in the County of Staffordshire.

The effect of the Order, which comes into force on 30 October 2008, will be to prohibit vehicles—

- (a) with an operating weight exceeding 7.5 tonnes, to wait at any time in the layby adjacent to the eastbound carriageway of the A50 between points 215 metres and 403 metres southeast of the centrepoint of the roundabout junction of the A50 with the A520 Weston and A520 Sandon Road, and
- (b) waiting in the layby described in a) above for a period exceeding 2 hours between the hours of 8.00am and 6.00pm, Monday to Friday, with no return within one hour.

Exemptions will be provided which will include emergency vehicles, delivery and service vehicles, disabled person's vehicles and vehicles being used in connection with any building operation or demolition, the removal of any obstruction to traffic or the maintenance of the road or the services therein.

Any person wishing to question the validity of, or of any provision contained in, the Order, on the ground that it is not within the powers with respect to the Order conferred by the above Act, or on the ground that any requirement of, or of any instrument made under, any provision of that Act has not been complied with in relation to the Order may, within 6 weeks of 23 October 2008, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
