AMENDMENT TO WAITING RESTRICTIONS IN VARIOUS STREETS IN THE CITY

1. NOTICE IS HEREBY GIVEN that the Common Council of the City of London on 31 October 2008 made an order under section 6 of the Road Traffic Regulation Act 1984.
2. The effect of the Order will be to change the hours during which the prohibition on waiting by vehicles apply, so that such prohibition will apply at any time in the streets and lengths of streets specified in the Schedule to this Notice.
3. A copy of the order which will come into operation on 10 November 2008 and of plans showing the affected streets can be inspected during normal office hours on Monday to Fridays inclusive until the end of six weeks from the date on which the order was made at the Department of Planning and Transportation, Guildhall, London, EC2P 2EJ.

5. Any person desiring to question the validity of the order or of any provision contained therein on the ground that it is not within the powers of the relevant section of the Road Traffic Regulation Act 1984, or that any of the relevant requirements thereof or of any relevant regulations made thereunder has not been complied with may, within

six weeks from the date on which the order was made, make application for the purpose to the High Court.
