##### ROAD TRAFFIC REGULATION ACT 1984

##### THE A38 TRUNK ROAD (VOSS FARM INTERCHANGE, NEAR PLYMPTON, DEVON) (SLIP ROAD CLOSURE) (EXPERIMENTAL) ORDER 2008

NOTICE IS HEREBY GIVEN that The Secretary of State for Transport has made an Order under sections 9(1) and (3) and 10(1) and (2) of, Section 14(1) of, and paragraph 27(1) of Schedule 9 of, the Road Traffic Regulations Act 1984, on the A38 Trunk Road in the District of South Hams, in the County of Devon.

The effect of the Order is to authorise the closure of the eastbound entry slip road of the A38 Trunk Road at Voss Farm Interchange. The Order, which is an experimental Order, will come into force on 4 December 2008 and remain in force for no longer than eighteen months.

Traffic movements and the closure will be monitored during the experimental period and the Secretary of State will be considering in due course whether or not the provisions of the Order should continue in force indefinitely. Within a period of six months from the coming into force of the Order, or, if the Order is subsequently varied by another Order under section 9 or modified pursuant to section 10 of the 1984 Act, from the coming into force of that variation or modification (whichever is the latest), any person may object to the making of an Order for the purpose of such indefinite continuation. Any objections must be made in writing, clearly stating the grounds of objection, to the Project Sponsor Alan Conibere at the Highways Agency, Network Operations, Ash House, Falcon Road, Sowton Industrial Estate, Exeter EX2 7LB, quoting reference HA 41/29/290. The A38 Trunk Road (Voss Farm Interchange, Near Plympton) (Temporary Prohibition of Traffic) Order 2007 is revoked.

ANY PERSON wishing to question the validity of, or of any provision contained in, the Order, on the ground that it is not within the powers with respect to the Order conferred by the above Act, or on the ground that any requirement of, or any instrument made under, any provision of that Act has not been complied with in relation to the Order, may within six weeks from 13 November 2008, apply to the High Court for the suspension or quashing of the Order or any provision contained in it.

##### THE HAVERING (WAITING AND LOADING RESTRICTION) (CIVIL ENFORCEMENT AREA) (NO. 1) (AMENDMENT NO. 111) ORDER 2008.

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Havering, hereinafter called the Council, on 24 November 2008 made the above-mentioned Order under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984.

2. The effect of the Order will be to introduce waiting restrictions operative "at any time" on the lengths of streets specified in the Schedule to this Notice.

Any person desiring to question the validity of the Order or of any provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984, or that any of the relevant requirements thereof or of any relevant regulations made thereunder has not been complied with in relation to the Order may, within six weeks of the making of the Order, make application for the purpose to the High Court.

##### TOWN AND COUNTRY PLANNING ACT 1990
