Preface

Content and Layout

This list contains details of the statutory publications and accompanying Explanatory documents published during the month. It is arranged in three main sections that group the primary and delegated legislation of the United Kingdom, England & Wales, Scotland and Northern Ireland (Statutory Instruments made by the National Assembly for Wales are included within the UK section). Within each section the publications are listed in the same order:

- Acts and their Explanatory Notes;
- Statutory Instruments or Statutory Rules, arranged under subject headings. (Each entry includes, where available or appropriate: the enabling power; the date when the instrument was issued, made and laid and comes into force; a short note of any effect; territorial extent and classification; a note of the relevant EU legislation; pagination; ISBN and price);
- A numerical listing of the instruments, with their subject heading. This list also includes any subsidiary numbers in the series: C for commencement orders; L for instruments relating to court fees or procedure in England and Wales; NI for Orders in Council relating only to Northern Ireland; S for instruments relating only to Scotland, W for instruments made by the National Assembly for Wales;

There is a single alphabetical, subject index, which includes both subject headings and descriptive terms from the title. The index is cumulated throughout the year

Unpublished Statutory Instruments

Although the majority of Statutory Instruments are formally published, some SIs of limited, local application are unpublished. These are listed in this publication when they have been received and processed by the TSO Bibliographic Department, not necessarily in the month they are issued. This causes some discontinuity in the number sequence, which is resolved in the annual listing, which lists the complete number sequences.
