(all measurements are approximate)

Description of the areas of highway to be stopped up under this Order
An irregularly shaped area of unnamed highway categorised as the U4224, with a maximum length of 272 metres and a maximum width of 10 metres, which extends from a point 15 metres east of Kerry Road to a point 77 metres south east of Pool Road (identified as A on the deposited plan).

An irregularly shaped area of highway known as Smithfield Road, with a maximum length of 48 metres and a maximum width of 16 metres, that extends from a point 6 metres south of its junction with Pool Road to a point 54 metres south east of Pool Road (identified as B on the deposited plan).

SCHEDULE 2

Description of the new highway to be provided

A length of footway/cycleway and irregularly shaped area of highway, measuring 450 square metres, that extends from the south eastern end of Sheaf Street to Pool Road (identified as C on the deposited plan).

An irregularly shaped area of highway to the south east of Pool Road, measuring 2,395 square metres, which will form a new signalled junction, the new access road to the development and the widening of part of the U4224 (identified as D on the deposited plan).

An irregularly shaped area of highway and footway, measuring 22 square metres, adjacent to No.8 Maesderwen (identified as E on the deposited plan).

A roughly rectangular area of highway, measuring 141 square metres, to the east of the U4224 (identified as F on the deposited plan).

SCHEDULE 3

Description of the highway to be improved

An irregularly shaped area of highway known as Pool Road that extends in a north easterly direction from a point north of No. 5 Smithfield Houses to a point north of No.8 Maesderwen, including a length of the U4224 that extends from its junction with Pool Road in a south easterly direction for 80 metres, all measuring 1,705 square metres (identified as G on the deposited plan).

The erection of a Tesco retail store and petrol station with associated car parking facilities, highway alterations and ancillary works at the former Smithfield Market site and bus depot in Newtown, Powys, in accordance with planning permission granted by Powys County Council on 18 February 2009 under reference M/2006/0510.
