### City of London

#### ROPEMAKER STREET – RELOCATION OF A TAXI PARKING BAY/ADDITIONAL LOADING RESTRICTION

1. NOTICE IS HEREBY GIVEN that the Common Council of the City of London on 3 July 2009 made orders under section 6 of the Road Traffic Regulation Act 1984.

2. The effect of the orders will be to:

- (a) reduce in length a taxi parking bay on the south side of Ropemaker Street; and
- (b) prohibit waiting by vehicles including waiting for the purpose of loading or unloading etc. At any time on the south side of Ropemaker Street, between Moor Lane and the revised location of the above taxi bay.

3. A copy of the orders, which will come into operation on 13 July 2009 and of a plan of the affected street, can be inspected during normal office hours on Monday to Fridays inclusive until the end of six weeks from the date on which the orders were made at the Department of Planning and Transportation, Guildhall, London, EC2P 2EJ.

5. Any person desiring to question the validity of the orders or of any provision contained therein on the ground that it is not within the powers of the relevant section of the Road Traffic Regulation Act 1984, or that any of the relevant requirements thereof or of any relevant regulations made thereunder has not been complied with may, within six weeks from the date on which the order was made, make application for the purpose to the High Court.

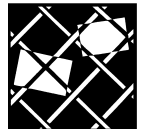
#### TOWN AND COUNTRY PLANNING ACT 1990
