INTRODUCTION OF "AT ANY TIME" DOUBLE YELLOW LINE WAITING RESTRICTIONS AT VARIOUS LOCATIONS

THE CITY OF WESTMINSTER (WAITING AND LOADING RESTRICTION) (AMENDMENT NO. 398) ORDER 2009

THE CITY OF WESTMINSTER (PARKING PLACES) (NO.38) ORDER 2009

1. NOTICE IS HEREBY GIVEN that Westminster City Council proposes to make the above Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.
2. The general effect of the Orders would be to:

(a) introduce "at any time" double yellow line waiting restrictions at the locations specified in the Schedule to this Notice;
(b) correct the Traffic Order designation of an existing parking place in Henderson Drive so that it reflects the on-street markings.

3. The Orders, which will come into force on 28th September 2009 and other documents giving more detailed particulars of the Orders are available for inspection until the 2nd November 2009 between 9 a.m. and 5 p.m. on Mondays to Fridays inclusive at One Stop Shop, City Hall, 62 Victoria Street, London, SW1E 6QP.

4. Any person desiring to question the validity of the Orders or of any provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984 or that any of the relevant requirements thereof or of any relevant regulations made thereunder have not been complied with in relation to the Order may, within six weeks from the date on which the Order was made, make application for the purpose to the High Court.
