### Warrants Under the Royal Sign Manual

Her Majesty The QUEEN has been graciously pleased by Warrant under her Royal Signet and Sign Manual bearing date 9 September 2009 to ordain and declare that James George Augustus Lumley-Savile, Peter Edward Henry Lumley-Savile and Robin William Matthew Lumley-Savile, the half-brothers of John Anthony Thornhill Baron Savile shall henceforth have, hold and enjoy the same title, rank, place, preeminence and precedence as sons of a Baron as would have been due to them had their late father, Henry Leoline Thornhill Lumley-Savile (commonly called the Honourable Henry Leoline Thornhill Lumley-Savile) survived his brother the late George Halifax Baron Savile, and thereby succeeded to the title and dignity of Baron Savile. And to command that the said Royal Concession and Declaration be recorded in Her Majesty's College of Arms.

### **Road Traffic Acts**

#### **Croydon Council**

PROPOSED 'PAY AND DISPLAY' 1 HOUR PARKING BAYS IN BRIGHTON ROAD, SOUTH CROYDON

1. NOTICE IS HEREBY GIVEN that Croydon Council propose to make a Traffic Order under Sections 45, 46, 49, 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by the Traffic Management Act 2004 and all other enabling powers.

2. The general effect of the Order would be to introduce 6 'pay and display' only bays operating between the hours of 10am and 4pm on Mondays to Saturdays inclusive in Brighton Road, (3 bays outside Nos. 556 to 562 Brighton Road and 3 bays outside the Post Office Sorting Office), to limit the maximum period for waiting in a parking place to 1 hour and to provide that the charge for leaving a vehicle vary from 20p for fifteen minutes up to 80p (maximum) for 1 hour (maximum).

A copy of the proposed Order and of all related Orders, of the Council's statement of reasons for proposing to make the Order and of the plans which indicate each length of road to which the Order relates, can be inspected during normal office hours on Mondays to Fridays inclusive until the last day of a period of six weeks beginning
