LONDON BOROUGH OF BARKING AND DAGENHAM (GASCOIGNE ESTATE, BARKING) (CONTROLLED PARKING ZONE) ORDER 2009

Notice is hereby given that The London Borough of Barking and Dagenham proposes to make the above Order under Sections 6, 32, 49, 121A, 124 and Parts I to IV of Schedule 9 of the Road Traffic Regulation Act 1984 as amended and all other enabling powers.

The area designated as a Controlled Parking Zone is that which is bordered by a broken red line on Drawing No.0010, Project No.LN01179 and comprises the following roads known locally as Gascoigne Estate:

Abbey Road, Boundary Road, Dovehouse Mead, Gascoigne Road, Hardwicke Street, Linsdell Road, St. Ann's, St. Margaret's, St. Mary's, The Coverdales, The Shaftesburys, Tomlins Orchard and Wheeler's Cross.

The effect of the Order will designate all existing parking places throughout the estate for the use of resident permit holders and provide additional spaces wherever possible. The times of operation will be between 8.30am and 9.00pm on Monday to Saturday inclusive and a general exemption will be included for non-permit holders to wait for 1 hour, return prohibited within 2 hours.

In addition, residents will be able to purchase Visitor Permits and provision will be made for the issue of Essential Health Worker and Operational Permits for essential users where necessary. Business Permits may be purchased for use in the parking places in Abbey Road only. A number of parking spaces for Disabled Persons will be designated throughout the estate and Disabled Badge Holders, resident or otherwise, will be allowed to park for unrestricted lengths of time free of charge in any designated parking place within the Zone.

- 1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Tower Hamlets on 4 December 2009 made the above-mentioned Order under the relevant sections of the Road Traffic Regulation Act 1984, as amended by Section 5 of the Local Government Act 1985 and the Traffic Management Act 2004.
- 2. The general effect of the Orders will be to:-
- (a) prohibit vehicular traffic from proceeding in Tapp Street, between its junction with the southern kerbline of Three Colts Lane and its junction with the northern kerbline of Cudworth Street, in a direction other than north to south in the southbound direction;
- (b) remove all existing parking bays in Tapp Street between Three Colts Lane and Cudworth Street and to introduce At Any Time Waiting and Loading Restrictions in this section;
- (c) introduce a Motorcycle Parking bay and a Disabled Parking bay in Tapp Street near Three Colts Lane.
- 3. The Regulations, fees and usual exemptions imposed by the governing Traffic Management Orders would apply to the proposals referred to in paragraph above.
- 4. A copy of the Orders, which will come into operation on 14 December 2009 and all relevant documents can be inspected at the Parking Services Offices, Mulberry Place (AH), Clove Crescent, London E14 2BE by prior appointment during normal office hours on Monday to Friday inclusive until the end of six weeks from the date on which the Orders were made.
- 5. Any person desiring to question the validity of the Orders or of any provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984, or that any relevant requirements thereof or any regulations made thereunder has not been complied with in relation to the Orders may, within six weeks of the date on which the Orders were made, make application for the purpose to the High Court.
