1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Islington on 7 December 2009 made the above mentioned Orders under Sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended.

2. The general effect of the Orders will be:

(a) in Eden Grove to convert the existing solo motorcycle parking place on the south east side, outside Nos. 1 to 7 Eden Grove to a residents bay and to convert 11 metres of shared use parking space (business permit holders and pay and display) on the north west side opposite the junction of Hartnoll Street to a solo motorcycle parking place;

(b) in Market Road to introduce five new disabled persons' "blue badge" parking bays on north side, adjacent to the offices of Scope, No. 6 Market Road;

(c) to provide "at any time" waiting restrictions in the lengths of street referred to in Schedule 1 to this Notice;

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Islington on * made the above Orders under Sections 6, 45, 46, 49 and 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended.

2. The general effect of the waiting and loading restriction Order will be to:

(a) vary the hours during which waiting is prohibited (other than for the purpose of loading or unloading a vehicle) so that the restrictions apply at the times and in the lengths of street referred to in Schedule 1 to this Notice;

(b) vary the hours during which loading restrictions are in force so that in Balls Pond Road they apply at the times and in the lengths of street referred to in Schedule 2 to this Notice. Any other existing loading restrictions in Balls Pond Road will be removed.

3. The general effect of the bus priority Order will be to provide sections of carriageway in which all vehicles other than buses, bicycles and taxis will be prohibited from proceeding between 7 a.m. and 7 p.m. on Mondays to Saturdays inclusive in the lengths of street referred to in Schedule 3 to this Order:

SCHEDULE 1

Provision of 'at any time' waiting restrictions

Balls Pond Road, the north side

between a point opposite the easternmost wall of No. 102 Balls Pond Road and a point 17.2 metres west of the western wall of No. 54 Balls Pond Road;

provision of waiting restrictions between 7 a.m. and 10 a.m. and between 4 p.m. and 7 p.m. on Mondays to Fridays inclusive.

Balls Pond Road, the north side

between a point 2 metres west of a point opposite the party wall of Nos. 38 and 40 Balls Pond Road and a point 4 metres west of the south-eastern kerb line of Kingsland Passage;

provision of waiting restrictions between 8 a.m. and 7 p.m. on Mondays to Saturdays inclusive that are non-match days, between 8 a.m. and 8.30 p.m. on Mondays to Fridays inclusive that are match days, between 8 a.m. and 7 p.m. on Saturdays that are match days and between noon and 4.30 p.m. on Sundays and Bank holidays that are match days.

Balls Pond Road, the north side

between a point 17.2 metres west of the western wall of No. 54 Balls Pond Road and a point 2.5 metres east of a point opposite the party wall of Nos. 42 and 44 Balls Pond Road;

SCHEDULE 2

provision of loading restrictions between 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive

Balls Pond Road, the north side

(v) between the western kerb-line of Mildmay Park and the common boundary of Nos. 120 and 122 Balls Pond Road;

provision of loading restrictions between 7 a.m. and 10 a.m. and between 4 p.m. and 7 p.m. on Mondays to Friday inclusive.

Balls Pond Road, the north side

between a point 29 metres west of the western kerb-line of Culford Road and a point opposite the south-eastern wall of No. 22 Balls Pond Road;

provision of loading restrictions between 8 a.m. and 9.30 a.m. and between 4.30 p.m. and 6.30 p.m. on Mondays to Fridays inclusive.

Balls Pond Road, the north side

between a point opposite the south-eastern wall of No. 22 Balls Pond Road and the boundary of the London Borough of Hackney;

SCHEDULE 3

Bus Priority Lanes

Balls Pond Road, the north side, between a point 2.7 metres east of the party wall of Nos. 98 and 100 and a point 3.2 metres east of the party wall of Nos. 32 and 34 Balls Pond Road. (994162)
