1. **NOTICE IS HEREBY GIVEN** that the Council of the London Borough of Bexley propose to make the above mentioned Orders under sections 6, 45, 46, 49, 51 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Orders, in amending the Bexley (New Eltham) (Parking Places) Traffic Order 2008, the Bexley (Pinnacle Hill) (Parking Places) Traffic Order 2008, the Bexley (Falconwood) (Parking Places) Traffic Order 2008, the Bexley (Welling Town Centre) (Parking Places) Traffic Order 2009 and the Bexley (Erith Town Centre) (Parking Places) Traffic Order 2009 would be to make some minor amendments to the Scheduled definitions of parking places in those Orders without making any actual changes to those parking places on the highway. The scheduled parking place definitions affected will be for various parking places in Brendon Road, Chartwell Close, Cornwallis Avenue, Dulverton Road, Ermington Road, Oakley Drive, Old Farm Avenue, Sidewood Road, Telford Road, Epsom Close, Martens Avenue, Martens Close, Pinnacle Hill North, Braywood Road, Northumberland Avenue, Sutherland Avenue, The Green, Lingfield Crescent, Winscrofts Drive, Coton Road, Springfield Road, Welling High Street, Bellegrave Road, Churchfield Road, Danson Crescent, New Road, Porthkerry Avenue, Marlwood Close, Saltford Close, Walnut Tree Road, Bexley Road, Victoria Road and Erith High Street.

3. Copies of the proposed Orders, any related parent Orders, the Council's statement of reasons for proposing to make the Orders, and maps which indicate the length of roads to which the Orders relate can be inspected during normal office hours on Mondays to Fridays inclusive for a period of 21 days commencing from the date of this Notice at the Contact Centre, Civic Offices, Bexleyheath, Kent DA6 7LB.

5. Any person desiring to object to the proposed Orders should send a statement in writing of their objections and the grounds thereof, to Traffic and Road Safety Group, Wyncham House, 2nd Floor, 207 Longlands Road, Sidcup DA15 7JH within the above 21 days.

6. Persons objecting to the proposed Orders should be aware that in view of the Local Government (Access to Information) Act 1985 this Council would be legally obliged to make any comment received in response to this Notice, open to public inspection.
