This Day the Right Honourable John Lord Carteret, was, by His Majefty's Gommand, Iworn one of the Lords of His Majefty's most Honourable Privy Council; as likewife one of His Majefty's Principal Secretaries of State, and took his Place at the Board accordingly.

Madrid, Feb. 24. The Marquels de Lede is not yet arrived at Court, being taken up with fettling the necessary Dispositions for fublifting the Troops commodi-ouly in their Quarters. Don Carlos Don Carlos Grillo who commanded the naval Forces in the late Expedition to Africa, is promoted to the Rank of Lieutenant General; as is also Don Ferdinand Chacon, Commodore of a Squadron. Sig. Pretis who brought hither from Rome the Cap for Cardinal Beluga, and has fince been employed by the Pope's Orders in collecting Informations for compleating the Process formed at Rome against Cardinal Alberoni, has taken his Leave of the Court in order to return home; his Behaviour having been to acceptable here, that the King has let-eled upon him a yearly Pension of a considerable Value. Our last Advices from Ceuta fay, the Army of the Moors continues in that Neighbourhood, but without having yet made any Dispositions for renewing the Siege of that Place: The Buildings they had crected in their former Camp were burnt by Orderof the Marquels de Lede, and the Works he had made for its greater Security were levelled, before he quitted it to retire into the Town.

Paris, March 12. The Turkish Ambaf-Iadour arrived here on the 8th Instant, accompanied by his Son and a numerous Retinue. He is lodged in the Fauxbourg St. Antoine, where he is to continue till he makes his publick Entry, the Day of which is not yet fixed. He is daily visited by a great Number of Persons of Diffunction of both Sexes, den, was arrived at Petersbourg.

A Council of Regency was held on the 9th, wherein it was refolved to fend back to the Parliament the Affair of the Duke de la Force, the Cognizance of which had been removed from that Court to the Privy Council. The Parliament accordingly met on the roth Inftant, and after having regiftred the Arrêt given for that Parpose, they proceeded to the Examina-tion of the Duke de la Force, who appeared without his Sword, which he had before refused to submit to. Several of the Offices appointed for the Examination of all the Paper-Effects were opened on the 10th Inflant; but it is not yet known whether the Actions of the India Company will be fubject to that Examination, no Refolution being yet taken by the Court upon the Petition lately prefented by that Company against the Arrêt of the 26th of January laft. Letters from Toulon relate, that above 40 Houses in that Town infected with the Plague were thut up, and that they were in great Apprehenfions of its fpreading further.

Hague, March 11. Moft of the Members of the States of the Province of Holland are already arrived here, in order to their allembling To-Morrow. It is reported that the Difficulties which have hitherto obstructed the Design of Farming the Cuftoms are now removed, and that before this Affembly feparates, that Project will be fixt , the Affair of the Loan of Money for the Expence of fitting out the Squadron defigned to act against the Algerines, and other Pyratea in the Mediterranean, will likewife be concluded in this Seffion. The Councilof State having lately caufed a Toll to be established at Grave, and the Novelty of that Proceeding having occasioned Tumults there, and Disputes with the Court of Brabant, it has been judged proper to lay aside that Design, and accordingly the Council of State have declared in form to the States General that they entirely give it up.
