
# Warrants Under the Royal Sign Manual

1. NOTICE IS HEREBY GIVEN that on 9<sup>th</sup> April 2010 the Council of the London Borough of Hackney made the above-mentioned Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended by the Local Government Act 1985 and the Traffic Management Act 2004. 2. The general effect of the Orders will be to:-

(a) change two existing general permit bays in Ardleigh Road to resident permit only parking bays;

(b) extend a section of residents permit holders only bay replacing an existing section of waiting restrictions operating "at any time" in Ardleigh Road.
