#### **KNIGHT'S HILL – INTRODUCTION OF “AT ANY TIME” WAITING RESTRICTIONS**

*[This notice is about the introduction of “no waiting at any time” restrictions (double yellow lines) in a part of Knight’s Hill.]*

1. NOTICE IS HEREBY GIVEN that Lambeth Borough Council on 23<sup>rd</sup> April 2010 made the Lambeth (Waiting and Loading Restriction) (Amendment No. 186) Order 2010, under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984. The Order will come into force on 3<sup>rd</sup> May 2010.
2. The general effect of the Order will be to impose “at any time” waiting restrictions on vehicles (double yellow lines) on the west side of Knight’s Hill, between the southern arm of Nettlefold Place and a point 49.5 metres south of the northern wall of No. 26 Knight’s Hill (the point where the zebra crossing zig-zag markings begin, just south of Hannen Road, which is equivalent to a point 26 metres south of the common boundary of Nos. 32 and 34 Knight’s Hill). This will be instead of the existing single yellow line waiting restrictions that currently operate between 7 am and 7 pm on Mondays to Saturdays and a length of bus stop clearway restrictions.
3. The Order is necessary to keep kerb-side space available at all times for the loading and unloading of vehicles outside “Horns Tavern” public house.

6. If any person wishes to question the validity of the Order or of any of its provisions on the grounds that it or they are not within the powers conferred by the Road Traffic Regulation Act 1984, or that any requirement of that Act or of any instrument made under that Act has not been complied with, that person may, within 6 weeks from the date on which the Order is made, apply for the purpose to the High Court.

#### **THE LONDON BOROUGH OF MERTON (PROHIBITION OF STOPPING ON CAB RANKS) (COOMBE LANE) TRAFFIC ORDER 2010**

##### **COOMBE LANE, SW20**

1. NOTICE IS HEREBY GIVEN that the London Borough of Merton, have made the above mentioned Order under Section 6 of the Road Traffic Regulation Act 1984 (therein after referred to as the Act), and all other enabling powers. The Order was made on 28<sup>th</sup> April 2010 and shall become operational on 29<sup>th</sup> April 2010.
2. The general effect of the Order will be to continue in force the experimental traffic management order giving effect to a taxi cab rank for the use by hackney carriages operating Monday to Saturday between 10am and 4pm and between 7pm and 7am, and all day Sunday on the south side of Coombe Lane, from a point 2.7 metres west of a point opposite the common boundary of Nos. 26/24 Coombe Lane, westwards for a distance of 13.4 metres.
3. A copy of the Order, a plan identifying the area affected by the Order, and the Council’s Statement of Reasons for making the Order can be inspected during normal office hours on Mondays to Fridays inclusive at Merton Link, Merton Civic Centre, London Road, Morden, Surrey.
4. Any person desiring to question the validity of the Order or of any provision contained therein on the grounds that it is not within the relevant powers of the Act, or that any of the relevant requirements of the Act, or of any relevant regulations made under that Act have not been complied with in relation to the Order may, within six weeks from the date on which the Order was made, make an application for the purpose to the High Court.
