## Road Traffic Acts

### London Borough of Havering

#### THE HAVERING (WAITING AND LOADING RESTRICTION) (CIVIL ENFORCEMENT AREA) (NO. 1) (AMENDMENT NO. \*\*) ORDER 200\*

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Havering, hereinafter called the Council, propose to make the above-mentioned Order under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Order would be to introduce waiting restrictions operative at any time on the lengths of streets specified in the Schedule to this Notice.

3. 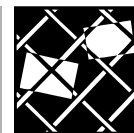
**Hog Hill Road**, the north side, between its junction with Lodge Lane and the common boundary of Nos. 2 and 4 Hog Hill Road.
