Road Traffic Acts

London Borough of Sutton

THE SUTTON (OFF-STREET PARKING PLACES) (NO. *) (AMENDMENT NO. *) ORDER 201* [REFERENCE OF813] RELATING TO CERTAIN CAR PARKS IN THE LONDON BOROUGH OF SUTTON

1. **NOTICE IS HEREBY GIVEN** that the Council of the London Borough of Sutton proposes to make the above named Order under sections 35 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.

2. The principal objectives of the Order are to make paying the parking charges in the Council's surface car parks easier by giving drivers the alternative method of paying by mobile phone, also to better control the use of free parking for the first 2 hours in the Stone Place Car Park by stipulating that drivers must display a pay and display ticket in their vehicle, and to remove Rosehill Car Park from the existing Order because it no longer exists.

3. The general effect of the Order would be:

(a) to allow the payment of parking charges to be made using a mobile phone together with a credit or debit card, in the following car parks: Cheam Library Car Park, High Street Car Park (Carshalton), Kingsway Road Car Park (Cheam), Melbourne Road Car Park (Wallington), Public Hall Car Park (Wallington), Shotfield Car Park (Wallington), Stone Place Car Park (Worcester Park), The Square Car Park (Carshalton) and Wallington Library Car Park (details of how to use this facility would be displayed in each of the car parks and the opportunity to pay by cash would still be available);

(b) to provide that in the Stone Place Car Park (Worcester Park), parking for the first 2 hours (or less) would continue to be free of charge but during that time a free pay and display ticket obtained from a ticket machine must be displayed appropriately on the vehicle;

(c) to remove Rosehill Car Park (Sutton) from the existing Order.

4. A copy of the proposed Order, the Council's Statement of Reasons for proposing to make the Order (and the Order that would be amended by the proposed Order), may be inspected at the Council's Civic Offices at St. Nicholas Way, Sutton and at the Environment and Leisure Offices at 24 Denmark Road, Carshalton, between 9am - 5pm Monday to Friday.

WESTCROFT LEISURE CENTRE CAR PARK

1. **NOTICE IS HEREBY GIVEN** that the Council of the London Borough of Sutton proposes to make the Order detailed below under sections 32, 35 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985, the Road Traffic Act 1991 and the Traffic Management Act 2004.

2. The title of the Order is **The Sutton (Off-Street Parking Places) (Leisure Services) (No. *) (Amendment No. *) Order 201***.

3. The principal objective of the Order is to prevent out of hours use of the Westcroft Leisure Centre Car Park by prohibiting overnight parking. This is to be regulated by the installation of a low barrier within the leisure centre car park approach road.

4. The general effect of the Order will be to: -

(a) change the hours of operation of the Westcroft Leisure Centre Car Park as follows;
