CHANCERY LANE AREA – STREET IMPROVEMENTS/ ADDITIONAL PAY AND DISPLAY PARKING

- 1. NOTICE IS HEREBY GIVEN that the Common Council of the City of London propose to make orders under section 6 and section 45 of the Road Traffic Regulation Act 1984.
- 2. It is proposed to close St.Pauls Coach Park and landscape the area. Five coach parking bays would be relocated to Queen Victoria Street and the disabled persons bays relocated to Deans Court. In addition, five short term coach bays will be sited in Angel Street and St.Martins le Grand and two additional disabled persons bays provided in Godliman Street.
- 3. As part of street improvement scheme, it is proposed to provide seven additional pay and display parking bays in Chancery Lane. The improvements would also include the pedestrianisation of lengths of Breams Buildings and Cursitor Street.
- 4.
