STREET CAR PARKING PLACES) (AMENDMENT NO. 1) ORDER 2010

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Hammersmith and Fulham on 17th November 2010 made the above Orders under sections 35, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended. 2. The general effect of the Orders, which will come into operation on 22nd November 2010, will be:

(a) in the Council's Controlled Parking Zones K and L, to formally enable the use of residents' and business parking permits in the form of RFID transponder cards and in the Council's Controlled Parking Zone R, to formally enable the use of residents' and business parking permits in the form of infra-red devices (instead of paper parking permits);

(b) to formally enable residents' and business permit holders in the Council's Controlled Parking Zones K, L and R to use the above permits together with a mobile phone (or the Council's website) as a cashless method of paying to park, as an alternative to "pay and display," in all the Council's other Controlled Parking Zones and in the White City Off-Street Car Park.

3. The key features of the cashless method of paying to park will be as follows:

• The permit holder must first register with the service provider and provide their credit or debit card details to them for the purpose of paying the parking charge;

• Once registered, and on leaving a vehicle in a pay and display or shared use (residents/business/pay and display) parking place, the permit holder activates a parking period either by calling the automated telephone service operated by the service provider, or via the internet using their personal pages. The permit holder will need to give the 4 digit reference code for the Controlled Parking Zone within which they are parked. A similar process needs to be carried out to deactivate the parking period when leaving the parking place.

• Using the cashless method, the parking charge (which will be at the same rates as for "pay and display") will apply on a per minute basis rather than the 30 minute minimum that is charged using the pay and display method;

• If, for whatever reason, the cashless system does not work or function properly, the pay and display method of paying for parking must be used.

4. A copy of each of the Orders and of documents giving more detailed particulars can be inspected during normal office hours on Mondays to Fridays inclusive until the end of a period of 6 weeks beginning with the date on which the Orders are made, at the offices of **Transportation Policy Group**, **Highways and Engineering Division**, **Environment Department**, **Town Hall Extension**, **King Street**, **Hammersmith**, **W6 9JU**.

5. If any person wishes to question the validity of either the Orders or of any of their provisions on the grounds that it or they are not within the powers conferred by the Road Traffic Regulation Act 1984, or that any requirement of that Act or of any instrument made under that Act has not been complied with, that person may, within 6 weeks from the date on which the Orders are made, apply for the purpose to the High Court.
