Notice is given that the Secretary of State for Transport made The A303 Trunk Road (Hayes End Roundabout, South Petherton, Somerset) (Derestriction) and (40 mph Speed Limit) Order on 4 March 2011, coming into force on 31 March 2011, under section 82(2) and 83(1) and section 84(1)(a) and (2) of the Road Traffic Regulation Act 1984 on the A303 Trunk Road (the A303) in the District of South Somerset in the County of Somerset.
