1. NOTICE IS HEREBY GIVEN that Croydon Council propose to make Traffic Orders under the relevant sections of the Road Traffic Regulation Act 1984, as amended by the Traffic Management Act 2004 and all other enabling powers.

2. The general effect of the Orders would be to extend the Croydon East Outer Controlled Parking Zone:-

(a) introducing 8 hour 'pay and display/permit' parking bays in conjunction with 9am and 5pm, Mondays to Saturday inclusive waiting restrictions in Westbury Road (53 bays) and part of Sydenham Road (16 bays, both sides, from existing Zone boundary to party wall of Nos. 373 and 375);

(b) introducing 'At any time' waiting restrictions in Northcote Road, the south-east side, 10 metres either side of Westbury Road and on both sides of Westbury Road for 10 metres from that junction;

(c) existing 'At any time' waiting restrictions that apply in any of the above roads will remain.

Charges for parking in the bays will vary from 60p for 30 minutes to £5.00 for 8 hours (maximum).
