#### **Road Traffic Acts**

### The London Borough of Bexley

THE BEXLEY (OFF-STREET PARKING PLACES) (AMENDMENT NO. 1) TRAFFIC ORDER 2011

- 1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Bexley propose to make a Traffic Order under Sections 32, 35 and 124 of and Part III and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984.
- 2. The general effects of the Order would be:-

(a) to extend the days of operation of the following off street car parks from Monday to Saturday to Monday to Sunday (all week) and to provide that the charging hours and charging tariffs that apply between 8am and 6pm at those car parks, now also apply on Sunday;

Gayton Road, Felixstowe Road, Steynton Avenue, Nuxley Road, Bexley High Street, Thanet Road, Broadway, Avenue Road, Stonewood Road, Mill Road, Grassington Road, Sidcup Place, Main Road, Old Farm Avenue, Nags Head Lane, Westwood Lane, Nags Head Lane (overnight lorry car park) and Oaklands Road (overnight lorry car park);

(b) to extend the days of operation of the following off street car parks from Monday to Saturday to Monday to Sunday (all week) and to provide that the charging hours and charging tariffs that apply between 8am and 6pm on each day to now apply 24 hours (at all times);

Albion Road multi-storey, Albion Road/Highland Road Civic Offices and Albion Road (Oaklands);

(c) to extend the days of operation of the 24 hour car park at the Albion Road bowling centre from Monday to Saturday to Monday to Sunday (all week) and to provide that the 24 hour charging hours and charging tariffs now also apply on Sunday;

(d) to provide that the season tickets available for designated parking places in the Gayton Road, Felixstowe Road, Stonewood Road, Nagshead Lane, Westwood Lane, Albion Road multi-storey, Avenue Road, Albion Road bowling centre, Grassington Road, Main Road, Old Farm Avenue, Albany Park Station and Bexley High Street off street car parks be increased to the following rates:

# Monthly - £64.00, Quarterly - £190.00, Half yearly - £364.00, Annual - £684.00

(e) to provide that the season tickets available for designated parking places in the Nuxley Road and Mill Road off street car parks be increased to the following rates:

Monthly – £39.00, Quarterly - £115.00, Half yearly – £220.00, Annual - £414.00

(f) to provide that the season tickets available for designated parking places in the Broadway cinema, Albion Road (Oaklands) and Thanet Road off street car parks be increased to the following rates:

Monthly - £90.00, Quarterly - £265.00, Half yearly - £508.00, Annual - £954.00.

### London Borough of Bexley

THE BEXLEY (PARKING PLACES) (DISABLED PERSONS)(AMENDMENT NO ) TRAFFIC ORDER 20XX

- 1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Bexley propose to make the above mentioned Order under sections 6, 45, 46, 49, and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by Section 8 of and Part 1 of Schedule 5 to the Local Government Act 1985.
- 2. The general effect of the Bexley (Parking Places) (Disabled Persons)(Amendment No ) Traffic Order 20XX would be to:
- (a) designate parking places in which vehicles authorised by the Order may be left for a period during the permitted hours without charge in the roads specified in the Schedule to this Notice;
- (b) provide that the parking place will operate at any time throughout the week;
- (c) specify, in respect of the parking places in the roads in the Schedule, that disabled persons' vehicles displaying in the relevant position a disabled person's badge (commonly referred to as "the Blue Badge") issued by any local authority under the provisions of the Disabled Persons (Badges for Motor Vehicles) Regulations 1982, may be left therein:
- (d) provide that certain vehicles may wait in the parking places in certain circumstances, e.g. to allow persons to board or alight (maximum 2 minutes), to load or unload (maximum 20 minutes), etc., (e) revoke the existing parking places, 12 Barnfield Road, Belvedere; 73 Cumbrian Avenue, Bexleyheath; 11 Iron Mill Lane, Crayford; 171 Hill Brow, Crayford; 5 Ling Road, Erith; and 168 Hengist Road, Erith; and 5 Shirley Avenue, Bexley; and
- (f) introduce new parking bays as set out in the Schedule below.
- 3. Copies of the proposed Orders, the Bexley (Parking Places) (Disabled Persons) Traffic Order 2009 (and the Orders that have amended that Order); the Council's statement of reasons for proposing to make the Orders and a map which indicates the length of roads to which the Orders relate can be inspected during normal office hours on Mondays to Fridays inclusive, at the Contact Centre, Civic Offices, Bexleyheath, Kent DA6 7LB.

- 6. Persons objecting to the proposed Order(s) should be aware that in view of the Local Government (Access to Information) Act 1985 this Council would be legally obliged to make any comment received in response to this Notice, open to public inspection.
