### The Highways Agency ROAD TRAFFIC REGULATION ACT 1984

THE A500 TRUNK ROAD (M6 JUNCTION 15, NEWCASTLE-UNDER-LYME, STAFFORDSHIRE) (DERESTRICTION) ORDER 20XX

The Secretary of State for Transport hereby gives notice that he intends to make an Order under section 82(2) and 83(1) of, and paragraph 27(1) of Schedule 9 to, the Road Traffic Regulation Act 1984 on the A500 Trunk Road near Newcastle-under-Lyme in the County of

The effect of the order would be to maintain the national speed limit on the A500 Trunk Road from a point 126 metres east of the centre of its roundabout junction with the A519 and the slip roads leading to and from the M6 at Junction 15, to and including the circulatory carriageway of that roundabout, which would otherwise be subject to a speed limit of 30 miles per hour as a result of the street lighting installed on those lengths.

A copy of the draft Order, together with plans illustrating the proposals and a Statement of the Secretary of State's reasons for proposing to make the Order, may be inspected during opening hours at Newcastleunder-Lyme Borough Council, Civic Offices, Merrial Street, Newcastle-under-Lyme, ST5 1AT; Newcastle Library, Ironmarket, Newcastle-under-Lyme, Staffordshire, ST5 1AT; or may be seen at or obtained by application to the Highways Agency, The Cube, 199 Wharfside Street, Birmingham, B1 1RN.

NOTICE IS HEREBY GIVEN that the Council of the London Borough of Brent have made the above mentioned Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by section 8 of and Part 1 of Schedule 5 to the Local Government Act 1985, the Parking Acts of 1986 and 1989 and the Traffic Management Act 2004

2. The general effect of the 'Disabled Persons Parking Places' Order will be to:-

(a) designate parking places in certain lengths of the streets specified in the Schedule to this Notice in which vehicles authorised by the Order may be left for any period without charge;

(b) provide that the parking places would operate "at any time"; (c) specify, in respect of the parking places, that disabled persons' vehicles displaying in the relevant position a disabled person's badge (commonly referred to as "the Blue Badge") issued by any local authority under the provisions of the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000 may be left therein;

(d) provide that certain vehicles may wait in the parking places in certain circumstances, e.g., to allow persons to board or alight (maximum 2 minutes), to load or unload (maximum 20 minutes), etc; (e) revoke existing disabled parking places outside No. 44 Douglas Road, NW6, No. 2 Minet Gardens, NW10 and No. 15 Rockhall Road,

3. The general effect of the 'Free Permit Parking Places' Order will be to revoke the existing personalised disabled persons parking places outside No. 62 Avonhurst House, Coverdale Road and No. 46 Ravensworth Road, NW10 provided by the Brent (Free Permit Parking

Places) (Disabled Persons) (No. 2) Order 2008. 4. The general effect of the 'Parking Places Amendment' Orders will

(a) increase in length the existing permit parking place in Douglas Road, the existing residents only parking place in Minet Gardens, the shared use parking place which operates between 12.30pm - 2.30pm on Fridays and permit parking place which operates between 10am – 9pm Mondays to Saturdays except Fridays between 12.30pm and 2.30pm in Rockhall Road following the revocation of no longer required disabled persons parking bays;

(b) shorten in length the existing permit parking places in Bathurst Gardens, Chapter Road, Kings Road and Windsor Road to enable for the installation of disabled person parking places

(c) shorten in length the existing Wembley Event Day parking place in Conduit Way to enable for the installation of a disabled person parking place opposite No. 7 Conduit Way;

(d) increase in length the existing shared use parking place in Coverdale Road and residents only parking place in Ravensworth Road following the revocation of no longer required personalised disabled persons parking bays

5. A copy of each of the Orders, which will come into operation on 17 October 2011, of maps of the relevant areas and of the above-mentioned Orders of 2001, 2004, 2008, 2010 (and of the Orders which have amended those Orders), 2004, 2005, 2006, 2007, 2008, 2009 and 2010, can be inspected during normal office hours on Mondays to Fridays inclusive until the end of six weeks from the date on which the Orders were made at:-

(a) The One Stop Local Office, Brent Town Hall, Forty Lane, Wembley, Middx, HA9 9HX; and

(b) The One Stop Local Office, Brent House, 349 - 357 High Road, Wembley, Middx, HA9 6BZ.

6. Copies of the Orders may be purchased from the address mentioned in paragraph 5(b) above.

7. Any person desiring to question the validity of any of the Orders or of any provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984 or that any of the relevant requirements thereof or of any relevant regulations made thereunder has not been complied with in relation to any of the Orders may, within six weeks of the date on which the Orders were made, make application for the purpose to the High
