##### NOTICE OF APPLICATION FOR AN ORDER FOR THE STOPPING UP OF PUBLIC FOOTPATH NO. 92 RYTON NEWBURN NEWCASTLE UPON TYNE

1. NOTICE IS HEREBY GIVEN that the Council of the City of Newcastle upon Tyne intends to apply to the Magistrates Court under Section 116 of the Highways Act 1980 for an Order stopping up the following area of highway being all of Footpath 92 Ryton on the grounds that it is unnecessary and the area of highway to be extinguished is shown marked by a solid black line on map reference no. FP92/SU/2011 ("the Order map") as follows:

(i) From point A which is located approximately 124 metres from the entrance to Tyne Riverside Country Park at Moore Court, in a westerly direction along the edge of the riverbank for approximately 337 metres to point B.

2. The application is to be heard on Tuesday 13 December 2011 at 10.00 am in Market Street Magistrates' Court, Newcastle upon Tyne.

3. The effect of the Order sought will be to prevent all pedestrian traffic over the land shown marked by a bold black line on the Order map which also may be inspected, free of charge, at the Customer Service Centre, Civic Centre, Newcastle upon Tyne between 8.30am and 4.30pm, Mondays to Fridays.

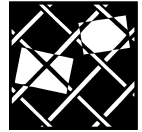

### CROSSRAIL ACT 2008

#### COMPULSORY PURCHASE (VESTING DECLARATIONS) ACT 1981

#### TO: PERSONS HAVING A RELEVANT INTEREST IN THE LAND DESCRIBED IN THE SCHEDULE HERETO

1. Notice is hereby given that the Crossrail Act 2008 ("the Crossrail Act") received Royal Assent on the 22 July 2008.

2. Transport for London is authorised by order of the Secretary of State for Transport under section 51 of the Crossrail Act to exercise powers under section 6(1) of the Crossrail Act to acquire compulsorily:-  
(a) so much of the land shown on the deposited plans within the limits of deviation for the scheduled works as may be required for or in connection with the works authorised by the Crossrail Act or otherwise for or in connection with Crossrail, and  
(b) so much of the land so shown within the limits of land to be acquired or used as may be so required.

3. The "scheduled works" are those specified in Schedule 1 to the Crossrail Act, being:-

(a) works for the construction of an underground railway between, in the west, a tunnel portal at Royal Oak in the City of Westminster and, in the east, tunnel portals at Custom House and Pudding Mill Lane in the London Borough of Newham,
