1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Waltham Forest propose to make the above-mentioned Orders under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Orders would be to:

- (a) introduce a disabled parking place for disabled blue badge holders operating "at any time" into a certain section of Cavendish Road;
- (b) introduce new, waiting restrictions, operating "at any time" into certain sections of Cavendish Road; and
- (c) formalise the existing traffic lane operation for vehicles turning from the north-east to south-west arm of Hall Lane into the north-west to south-east arm of Hall Lane.

3. Copies of the Orders, the Council's statement of reasons for proposing to make the Orders and of plans showing the location and effect of the Orders can be inspected during normal office hours on Mondays to Fridays inclusive until the end of a period of 6 weeks from the date on which the Orders are made or the Council decides not to make the Orders, at (a) the Information Desk, Town Hall, Forest Road, Walthamstow, E17 The Reception Desk and (b) the London Borough of Waltham Forest, Low Hall, Argall Avenue, London, E10 7AS.

4. Any person desiring to object to any of the Orders or to make any other representation should send a statement in writing of either their objection and the grounds thereof or of their representation to Traffic Orders, Engineering Design, Low Hall, Argall Avenue, London, E10 7AS, quoting reference T09, by the end of a period of 21 days from the date on which this Notice is published. All objections must specify the grounds on which they are made.

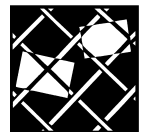
