London Borough of Bexley THE BEXLEY (MISCELLANEOUS PARKING PLACES) TRAFFIC ORDER 2012

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Bexley, have made the above titled Traffic Order on the 15th October 2012 under Sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 and all other enabling powers.

2. The general effect of the Order will be to revoke the Bexley (Miscellaneous Parking Places) (No. 1) Traffic Order 2011 regulating the use and enforcement of various isolated lengths of on-street parking places in the London Borough of Bexley lying outside the main area controlled parking zones, to reproduce and re-enact the articles and provisions of that Traffic Order without any change to their general effect and to consolidate and bring into one order all the modified provisions and parking places introduced by previous related amendment orders without any change to their lengths or locations.

3. Copies of the Order, which will come into effect on 22nd October 2012, of any related Orders and a Statement of Reasons for making the Order, will be available for inspection during normal office hours for a period of 6 weeks from the date of the making of the Order at the Contact Centre, London Borough of Bexley, Civic Offices, Bexleyheath, Kent DA6 7LB.

3 TONNES AND 18 TONNES WEIGHT RESTRICTIONS IN BLACKHORSE LANE

1. NOTICE IS HEREBY GIVEN that Croydon Council propose to make the Croydon (Weight Restriction) (No. z32) Traffic Order 2012 under Section 6 of the Road Traffic Regulation Act, 1984 as amended by the Local Government Act, 1985.

2. The general effect of the Order will be to prohibit vehicles:

(a) exceeding 18 tonnes maximum gross weight on the bridge in Blackhorse Lane situated from the party wall of Nos. 43 and 45 Blackhorse Lane north-westward for a distance of 38.00 metres;

(b) exceeding 3 tonnes maximum gross weight on the bridge in Blackhorse Lane situated from the south-eastern flank wall of No. 37 Blackhorse Lane south-eastward for a distance of 30.00 metres.

3. PROPOSED ONE-WAY WORKINGS IN BYNES ROAD AND ROLLESTON ROAD, SOUTH CROYDON AND WOODSIDE COURT ROAD, ADDISCOMBE

1. NOTICE IS HEREBY GIVEN that Croydon Council proposes to make a Traffic Order under Section 6 of the Road Traffic Regulation Act 1984, as amended and all other enabling powers.
