REVIEW OF LOADING RESTRICTIONS – VARIOUS STREETS

1. NOTICE IS HEREBY GIVEN that the Common Council of the City of London propose to make an order under section 6 of the Road Traffic Regulation Act 1984.
2. The effect of the order would be to revoke the restriction on loading and unloading in certain streets and lengths of streets in the City and change the hours during which existing restrictions on loading and unloading apply in other streets and lengths of streets throughout the City. The affected streets are listed in the Schedule to this Notice
