

- (a) Bedford Road: northbound and eastbound, between its junction with Chingford Road and its junction with Dudley Road;  
 (b) Bedford Road: southbound, between a point 30 metres north of the northern kerb-line of Forest Road and its junction with Dudley Road;  
 (c) Brettenham Road: eastbound, between a point 36 metres west of the western kerb-line of Chingford Road and its junction with Carr Road;  
 (d) Carr Road: northbound, between its junction with Brettenham Road and its junction with Winns Avenue;  
 (e) Jewel Road: northbound, between its junction with Forest Road and its junction with Hoe Street;  
 (f) Winns Terrace: southbound, between its junction with Forest Road and its junction with Winns Avenue.

3. Documents giving more detailed particulars of the Order are available for inspection between 9.30 am and 4.30 pm on Mondays to Fridays inclusive (except Bank Holidays), from the date on which this notice is published until the Order ceases to have effect, at (a) The Information Desk, Town Hall, Forest Road, Walthamstow, E17 4JF and (b) Low Hall Depot, Argall Avenue, London, E10 7AS.

4. Where it appears necessary for certain purposes, an officer authorised by the London Borough of Waltham Forest, may, in pursuance of section 10(2) of the Road Traffic Regulation Act 1984, modify or suspend any provision of the experimental Traffic Order while it is in force.

5. The Council will be considering in due course whether the provisions of the experimental Order should be continued in force indefinitely by means of permanent Order made under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984. Any person may object to the making of the permanent Order for the purpose of such indefinite continuation within a period of six months beginning with the day on which the experimental Order comes into force or, if the Order is varied by other Orders or modified pursuant to section 10(2) of the 1984 Act, beginning with the day on which the variation or modification or the latest variation or modification came into force. Any such objection must be made in writing and must state the grounds on which it is made and be sent to Traffic Orders, Environment and Regeneration, Low Hall, Argall Avenue, London, E10 7AS, quoting reference Traffic Orders T21. Any objection may be communicated to, or be seen by, other persons who may be affected.

6. If any person wishes to question the validity of the Order or of any of its provisions on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or that any requirement of that Act or any instrument made under that Act has not been complied with, that person may, within 6 weeks from the date on which the Order is made, apply for the purpose to the High Court.

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Waltham Forest propose to make the above-mentioned Orders under sections 6, 45, 84 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Orders would be to:

- introduce waiting restrictions operating "at any time" into certain sections of Bedford Road E17 and Brettenham Road E17;
- extend the lengths of existing waiting restrictions operating "at any time" in certain sections of Brettenham Road E17 and Winns Terrace E17 and waiting restrictions operating 8 a.m. and 9 p.m. throughout the week in Bedford Road E17;
- reduce the lengths of certain existing waiting restrictions operating 8 a.m. and 9 p.m. throughout the week in Bedford Road E17 and Winns Terrace E17;
- extend the lengths of certain existing LP-W zone permit holders parking places in Bedford Road E17;
- reduce the lengths of certain existing LP-W zone permit holders parking places in Winns Terrace E17; and
- introduce a 20mph Zone, with a maximum speed limit of 20 m.p.h. into the following roads; Bedford Road E17, Bromley Road E17, Chandos Avenue E17, Dudley Road E17, Farnan Avenue E17 and Kenilworth Avenue E17.

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Waltham Forest on 15<sup>th</sup> March 2013 made the above-mentioned Orders under sections 6, 45 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Orders will be to:

- amend the operational hours of the Whipps Cross North (WXN) Controlled Parking Zone (CPZ) from operating between 8.00 a.m. and 9.00 p.m. throughout the week to operating between 8.00 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive;
- extend the existing boundary of the CPZ to include West End Avenue; and
- introduce permit holder parking places into West End Avenue.

3. The Orders will provide that:

- the operational hours in the CPZ for permit parking places will be between 8.00 a.m. and 6.30 p.m. on Mondays to Saturdays;
- residents' permits, business/charity permits, visitors' permits, school parking permits, residents' foreign vehicle permits and essential user/carers permits may be issued, on payment of the appropriate charge, to a person who is the keeper of a passenger vehicle (having 8 passenger seats or less), certain goods carrying vehicles and invalid carriages, (motor cycles will be able to park in permit parking places, free of charge, without the need of a parking permit) providing that in the case of:
