PROPOSED EXTENSION OF SHERNHALL BAKERS ARMS CONTROLLED PARKING ZONE INTO VARIOUS ROADS E17 THE WALTHAM FOREST (SHERNHALL BAKERS ARMS CPZ) (PARKING PLACES) (AMENDMENT NO. 3) ORDER 2013 THE WALTHAM FOREST (FREE PARKING PLACES) (SHORT STAY) (AMENDMENT NO. 8) ORDER 2013 THE WALTHAM FOREST (WAITING AND LOADING RESTRICTIONS) (AMENDMENT NO. 26) ORDER 2013

- 1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Waltham Forest on 14th June 2013 made the above-mentioned Orders under sections 6, 45 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended, and intend to introduce footway parking places under the GLC General Powers Act 1974.
- 2. The general effect of the Orders will be to:
- (a) extend the existing boundary of the Shernhall Bakers Arms (SB) Controlled Parking Zone (CPZ) to include Addison Road, Barclay Road, Brunswick Street, Comely Bank Road, Cromwell Road, Grove Road (between its junctions with Cromwell Road and Shernhall Street), Maynard Road, Ravenswood Road, Salisbury Road and Wilson Street;
- (b) introduce permit holder parking places into Addison Road, Barclay Road, Brunswick Street, Comely Bank Road, Cromwell Road, Grove Road (between its junctions with Cromwell Road and Shernhall Street), Maynard Road, Ravenswood Road, Salisbury Road and Wilson Street, certain parking places in Cromwell Road will be located partially on the footway;
- (c) introduce shared permit holder and free, short term parking places into Ravenswood Road;
- (d) introduce unmarked parking controls into Barclay Road and Maynard Road which will allow permit holders to park anywhere within these
- (e) amend the layout of certain existing permit holder parking places in Brunswick Street, Comely Bank Road and Ravenswood Road.
- 3. The Orders will provide that:
- (a) the operational hours in the extension of the CPZ for all parking places will be between 10.00 a.m. and 4.00 p.m. on Mondays to Fridays
- (b) the shared use, free, short term parking places will have a maximum stay period of 1 hour with no return within 2 hours;
- (c) residents' permits, business/charity permits, visitors' permits, school parking permits, residents' foreign vehicle permits and essential user/ carers permits will be issued, on payment of the appropriate charge, to a person who is the keeper of a passenger vehicle (having 8 passenger seats or less), certain goods carrying vehicles and invalid carriages, (motor cycles will be able to park in permit parking places, free of charge, without the need of a parking permit) providing that in the case of:
- (i) a residents' permit, they are a resident of a street specified above and their vehicle is UK registered to that address;
- (ii) a foreign vehicles residents' permit, they are a resident of a street specified above and their vehicle is registered outside of the UK;
- (iii) a business/charity permit/business visitor's permit, they have a business in a street specified above and that the permit is for a vehicle which is essential to the operation of that business/charity and is used in the purchase and sale of goods or services in connection with that business/
- (iv) an essential users/carers permit, they are a doctor or carer who has a surgery in or works in the London Borough of Waltham Forest, or employed by or contracted to the Council, or employed by or contracted to a health authority, or employed by the Metropolitan Police, or employed by the London Fire and Civil Defence Authority, or a company that services fire fighting appliances and for whom the use of a vehicle is essential to the carrying out of their public service duties in a street specified above;
- (v) a visitors' permit, they are a resident of a street specified above and that such permit is to be used by a bona fide visitor to their home; (vi) a schools parking permit, they are a parent of a student enlisted at a school situated in or near to the streets specified above;
- (d) vehicles displaying any valid permit displaying the letters:
- (i) SB will be able use the permit parking places provided in the streets within the SB CPZ;
- (ii) except in the parking places referred to above, waiting by vehicles will be banned in the streets listed in paragraph 2(a) above between 10.00 a.m. and 4.00 p.m. on Mondays to Fridays inclusive; ["At any time" waiting restrictions in certain areas of certain streets listed in paragraph 2(a) above will also apply]

the charges for permits and vehicle class will be as follows:
