1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Bexley on 22nd July 2013 have made the above mentioned Orders under sections 45, 46, 49, 51 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.
2. The general effect of the Orders, in amending the Bexley (Bexleyheath Town Centre) (Parking Places) Traffic Order 2012 and the Bexley (Miscellaneous Parking Places) Traffic Order 2012 would be to provide 'pay and display' parking ticket machines as an alternative method of payment for parking places in the streets specified in the Schedule to this Notice. These parking places have a 2 hour maximum stay and operate between the hours of 8.30 a.m. and 5.30 p.m. on Mondays to Saturdays. There are no changes to existing charging tariffs.

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Bexley propose to make the above mentioned Orders under sections 6, 45, 46, 49, 51 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended, by Section 8 of and Part 1 of Schedule 5 to the Local Government Act 1985 and all other enabling powers
2. The general effect of the Bexley (Sidcup Town Centre) (Parking Places) (Amendment No.**) Traffic Order 20XX would be to further amend the Bexley (Sidcup Town Centre) (Parking Places) Traffic Order 2013, to:
 - remove St. John's Road, Craybrooke Road, Selborne Road and Rectory Close, Sidcup from the Sidcup Town Centre Controlled Parking Zone.
3. The general effect of the Bexley (Sidcup East) (Parking Places) Traffic Order 20XX would be to:
 - (a) introduce new parking controls operating between the hours of 9am and 8pm on Mondays to Saturdays inclusive in St. John's Road, Craybrooke Road, Selborne Road and Rectory Close, Sidcup to form a newly designated Controlled Parking Zone called Sidcup East Controlled Parking Zone. The locations of parking places in these roads will remain as existing but changes to the user type and duration of parking are proposed to reflect current demands; The proposed new CPZ will have free parking places, and parking places for the following types of permit holder ; resident, visitor and business.
 - (b) provide that resident parking permits would be available at a cost of £40 per quarter or £120 per annum in respect of each vehicle, to provide that business parking permits would be available at a cost of £70 per quarter or £200 per annum in respect of each vehicle or that books of 10 resident visitor permits would be available at a cost of £20 per book
4. The general effect of the Bexley (Waiting and Loading Restriction) (Amendment No.**) Traffic Order 20XX; would be to further amend the Bexley (Waiting and Loading Restriction) Traffic Order 2012, to change the existing single yellow line waiting restrictions applying between the hours of 9am to 5.30pm on Monday to Saturday to the hours of 9am to 8pm on Monday to Saturday inclusive, in St. John's Road, Craybrooke Road, Selborne Road and Rectory Close (in line with the Sidcup East CPZ operating hours).
