THE BRENT (WAITING AND LOADING RESTRICTION) (AMENDMENT NO. *) ORDER 201*

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Brent propose to make the above mentioned Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by section 8 of and Part 1 of Schedule 5 to the Local Government Act 1985, the Parking Acts of 1986 and 1989 and the Traffic Management Act 2004.

2. The general effect of the 'Disabled Persons Parking Places' Order would be to:-

(a) designate parking places in certain lengths of the streets specified in Schedule 1 to this Notice in which vehicles authorised by the Order may be left for any period without charge;

(b) provide that the parking places would operate "at any time";

(c) specify, in respect of the parking places, that disabled persons' vehicles displaying in the relevant position a disabled person's badge (commonly referred to as "the Blue Badge") issued by any local authority under the provisions of the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000 may be left therein;

(d) provide that certain vehicles may wait in the parking places in certain circumstances, e.g., to allow persons to board or alight (maximum 2 minutes), to load or unload (maximum 20 minutes), etc;

(e) revoke the existing disabled parking places outside No. 83 Braemar Avenue, Neasden, NW10 0DR, No. 15 Brooksville Avenue, NW6 6TH, No. 49 Brenthurst Road, NW10 2DX, No. 52 Chapter Road, NW2 5LG, No. 15 College Road, NW10 5EL, No. 22 Oxford Road, NW6 5SL, No. 55 Rucklidge Avenue, NW10 4QA and No. 34 Tennyson Avenue, NW9 9JA.

3. The general effect of the above 'Free Permit Parking Places' Order would be to:

(a) re-designate existing free parking places for vehicles displaying a disabled person's badge (commonly referred to as "the Blue Badge") in the streets specified in Schedule 2 to this Notice to free personalised parking places for vehicles displaying a Brent issued personalised disabled persons parking places permit issued under the Order;

(b) provide that the parking places would operate "at any time";

(c) provide that a permit may be issued by the Council on application being made by a disabled person in possession of a Brent issued blue badge and:

(i) in receipt of the Disability Living Allowance with the higher rate of mobility component for an indefinite period; or

(ii) in receipt of the higher rate of Attendance Allowance for applicants aged 65 or over; or

(iii) where the applicant does not drive and has appointed a nominated carer to drive for them, the carer is in receipt of the Carer's Allowance award;

(d) revoke the existing free personalised parking place outside No. 3 Kingswood Avenue, NW6 6LA and No. 2 Ridley Road, NW10 5UA.

4. The general effect of the 'Doctor Parking Places' Order would be to:-

(a) designate a parking place in Strode Road for No. 223 High Road, Willesden;

(b) provide that:

(i) vehicles displaying a permit issued under the Order may be left in the parking place;

(ii) the parking place would be in operation between 8.00 a.m. and 8.00 p.m. on any day of the week;

(iii) a permit may be issued by the Council on application being made by legally qualified medical practitioners;

(iv) the charge in connection with the issue of permits for the use of the parking place (which consists of one parking bay) would be £150 and that the permits would be valid for a period of 12 months.

5. The general effect of the 'Parking Places Amendment' Orders would be to:

(a) increase in length existing permit holders only parking places following the revocation of the no longer required disabled persons parking places or personalised disabled persons parking places in Brenthurst Road, Kingswood Avenue;

(b) shorten in length existing permit holders only parking places in Chambers Lane, Christchurch Avenue, Creighton Road, Doyle Gardens, Eton Avenue and Orchard Close to enable the installation of a disabled person parking place;

(c) shorten in length the existing shared use parking place in Strode Road to enable the installation of a doctor's parking place;

(d) shorten in length the existing shared use parking place in Cambridge Road to enable the installation of a disabled person parking place;

(e) shorten in length the existing Wembley Event Day parking place in Avondale Avenue to enable the installation of a disabled person parking place;

(f) make minor drafting amendments to certain existing Wembley Event Day parking places in Avondale Avenue.

6. The general effect of the The Brent (Parking Places) (No. 1, 2002) (Amendment No. *) Order 201* would be to:-

(a) designate parking places that would operate between 8.00 a.m. and 6.30 p.m. Mondays to Saturdays in certain lengths of the street specified in Schedule 3 to this Notice;

(b) specify that:-

(i) each parking place may be used, subject to the provisions of the Order, for the leaving during the permitted hours of such vehicles as are passenger vehicles, goods carrying vehicles or invalid carriages displaying a valid parking ticket or permit. Motor cycles park free;

(ii) the maximum period for which a vehicle, displaying a valid parking ticket may be left during the permitted hours in the parking places specified in Schedule 3 to this Notice would be 4 hours;

(iii) the charge for short term parking in the parking places specified in Schedule 3 to this Notice would be 60 pence for 20 minutes, £1.50 for 40 minutes, £2.40 pence for 1 hour, £6.00 for 2 hours and £9.00 for 4 hours the tickets for which would be issued by pay and display machines;

(iv) the interval before a vehicle may again be left in a parking place after the expiration of the period for which the parking charge was incurred would be 2 hours;

(v) any resident whose usual place of abode is in the street specified in Schedule 4 to this Notice may apply to the Council for the issue of a residents permit valid for use in the parking places specified in Schedule 3 to this Notice;
