THE A33 TRUNK ROAD AND THE A34 TRUNK ROAD (KINGS WORTHY – EASTON LANE INTERCHANGE) (50 AND 60 MILES PER HOUR SPEED LIMITS) ORDER 201

NOTICE IS HEREBY GIVEN that the Council of the London Borough of Barnet propose to make the above mentioned Orders under sections 6, 45, 46, 49 and 51 to the Road Traffic Regulation Act 1984 and all other enabling powers.

In order to provide a parking facility to disabled Blue Badge holders who meet qualifying criteria, the general effect of the Disabled Persons Designated Permit Parking Places Order would be to provide designated parking bays for use by motorists in their vehicles who display both a valid disabled Blue Badge and a 'disabled' parking permit which would be applicable to each bay, at the following locations:

21 East Crescent N11, 1 Halifax Broadhead Strand NW9, 21 Millfield Road HA8, 10 North Crescent N3 (by converting a disabled parking bay), 34 Pine Road N11, 48 Quinta Drive EN5, 39 Vernon Crescent EN4 and 2 Wimbush House Westbury Road N12.

The bays at 14 Babington Road NW4 and 27 Chapel Court N2 would be provided by converting existing resident permit parking spaces.
